As a candidate for the NYS Assembly, and as a lifelong resident of New York, I have been exposed to many different administrations on both the city and state level, from Former Governor Mario Cuomo to Former Mayor Rudy Giuliani, through to present administrations. I have witnessed how different leadership can have a major impact on the quality of life for New Yorkers. I have also witnessed how faulty policy decisions can have a lasting negative impact on the city and state-at-large.

One prominent matter, however, is the lack of government communication with the constituency. Some may say that the government does in fact communicate with the public through the media. However, this is not the communication to which I refer. What I am referring to is true one- on- one communication. For too long there has been a disconnect between the decision-making government and the citizenry. Why does the community feel disaffected with the government? The overwhelming feeling is that the government simply does not represent their needs. The taxpayer consistently feels shortchanged, receiving little benefit from those he entrusted with their quality-of-life.

Our government has changed, and so has its best interests. Instead of focusing on the people that make up this great state, they are more focused on the corporate donors and lobbyists they are beholden to. I share many of Citizen Union's views. We need a more transparent government, or we invite corruption. We need legislation that will push such an agenda and create a more level playing field so that each member of the legislature has a fair say in what goes on in Albany. We need more accountability when things go wrong and taxpayers' money is wasted. We need a more common sense approach to government, one that puts the people and their issues first, not those of the special interest groups, lobbying firms, and corporations. We need to change the system, ground up, so that those who have learned how to work it, can no longer take advantage of it. We need new representation, new perspectives, and more effective leadership that is more focused on good policies, rather than on the next election, and their contributors.

Many issues were featured in the questionnaire, as you can tell I support all the positions mentioned because they all come from a place of common sense. This is the type of approach we need, and more. We need to simplify the process so that we can have a more informed electorate making informed decisions that will ultimately lead to better government and a better state for all of us.

Comment on individual issues:

- The amendment ensures a much fairer redistricting process, although passage will not take effect until
 the next census, in 2020. A proposed statute limiting the legislature's power to appoint members to the
 redistricting commission, and to turn over appointing power to the governor if the houses fail to pass the
 amendment again next year should also be enacted, to ensure reform actually takes place.
- Amending the constitution to abolish the two-party system would go a long way toward ending the deadlock that characterizes many legislatures, both state and federal. The entire political party power structure would be weakened to the extent that elections would become more meaningful, allowing

- candidates who didn't have a chance to run, and making the citizen a much more meaningful part of the process.
- 3. The ballot system is open to abuse by clever and sinister challenges. While the system gets the candidates out into the community and gets them known, which is valuable, election lawyers can figure out ways to get them bumped off by challenging every technicality. Ballot access also clearly favors the incumbents, who are understandably quick to stymie the process of change.
- 4. The charter revision commission, as it stands, is clearly a political tool of the mayor, and serves in his best interest. I support the amendment which keeps the mayor's power and influence in check.
- Many New Yorkers on parole are now contributing members of society and must be allowed to
 participate in the process. The law barring them from voting can be easily construed as racist, as it mirrors
 similar laws from the Jim Crow era.
- Election Day Registration has proved to be a significant boost to voter turnout, and should be implemented with the proper requirements.
- 7. There are risks involved with no excuse voting. As long as these risks are carefully managed, it should be allowed, as it has proved successful elsewhere.
- 8. As above, early voting may be allowed and encouraged, as long as the risks are managed and made known to the voters casting ballots prior to the end of the campaign.
- Redesigning the ballot is a common-sense initiative to make the ballot more understandable to the voter, and to reduce error.
- The current process is nothing less than secretive and controlled by select party committees. A nonpartisan special election would be more reflective of the democratic process.
- 11. Automatic voter registration would streamline the system, which currently allows registration in a variety of methods, opening the possibility for fraud.
- 12. A system of public financing would tend to help level the playing field, and ameliorate the influence of special interests in getting their candidate elected. Such a measure would be difficult in present economic conditions, but must nonetheless receive support.
- 13. The contribution limits are too high, and should be more in line with local (NYC) levels.
- 14. This again is a common-sense issue restricting contributions from such entities greatly reduces the possibility of corrupting the system.
- 15. Limiting or banning the influence of such entities has, of course, been largely circumvented by action of the Supreme Court. This was an unfortunate decision, and will hopefully come up for review following the 2012 election cycle. On the state level, I would support legislation limiting such contributions, and in the case of LLPs and LLCs, identifying the principals involved.
- 16. Closing "soft-money" loopholes is vitally necessary to a full and fair election process. It simply allows the machine process to continue and perpetuate itself by getting its own players elected.
- 17. Including full identification for each source of campaign revenue allows any party to track and investigate as appropriate such sources. It is another control in the process that insures free and fair elections.
- 18. As before, such measures are designed to keep the process transparent, and I fully support such a measure.
- 19. Campaign contributions have no business being directed to personal use or other non-campaign activity. Such is not the intent of the contributors.
- 20. These are fairly simple bookkeeping requirements that all campaigns should adopt, if they have not already. Otherwise expenditures can become murky.
- 21. A "war chest" is intended for one campaign, only. The funds should pay off that campaign's debts, be returned to contributors, donated to charities, or turned over to the party. Contributors to whom the money is returned may feel free to contribute to the new campaign, if they so wish.

- 22. An independent enforcement entity could provide further separation from the potential for corruption; however, if the Board of Elections cannot do its job and provide full and fair enforcement, then we should be looking into why they cannot adequately perform their duties and work to resolve those issues instead of creating a separate entity to do the job for them.
- 23. If the commission is truly independent of political tampering, then I would support it. The current system is too vulnerable to political vagaries and must be reformed.
- 24. The current court system is antiquated and unwieldy. It is long past time to bring it up to modern-day standards. The efficiency of such a system would insure swifter justice and help ease taxpayer burden.
- 25. Allowing the attorney general to prosecute such violations of the public's trust would not only bring considerable resources into play, but also insure that the prosecution is kept clearly in the public arena, where it belongs.
- 26. Absolutely support such legislation. No one should be exempt from penalties for felony convictions.
- 27. Foregoing full disclosure would mean, in effect, hiding tens of billions in public-authority debt.

 Subsequent approved budgets would be meaningless without taking all obligations into consideration.
- 28. This is another common-sense proposal that can only benefit the state by removing the budget from the political fun-house mirror.
- 29. GAAP would require legislators to deal with current problems, rather than defer them to later years. This is a step in the right direction, although much could be accomplished by using balanced budget requirements already in place and unenforced.
- 30. The proposed legislation will provide for more equitable and transparent distribution of discretionary funding based on necessity, not power and influence. I will work for its passage.
- 31. Again, a common-sense measure that rewards achievement and progress, and would benefit all New Yorkers.
- 32. While a later start date would enable a more accurate read on projected tax revenue, the state budget is not the only one. City and county budgets are tied to and dependent on the state budget, so all entities must work together to the advantage of all.
- 33. The governor must act within the guidelines of the wishes of the people, as expressed through the elected legislature. Otherwise he has free reign to act like a maverick.
- 34. The more transparent the process is, the more responsive government will be.
- 35. Giving all members a say in the legislative process stanches the ability of the power structure to have its way in all matters; in other words the process is more democratic.
