



I support paying down debt whenever possible.

23. What is your view of how the taxes paid by New Yorkers compare to the value that is received in City services? Do you believe that taxes should be raised or lowered? To the extent you believe taxes should be changed, please provide specific proposals about what taxes you would raise and what services you would cut, if you didn't raise taxes, listed in order of greatest magnitude.

I support lowering taxes and a small government and believe my priorities have been made clear over the last 8 years.

As I have stated many times, we need pension and Medicaid reform and our fair share of state funding (Albany owes us \$14 billion). If this occurs, there's absolutely no reason to raise taxes or cut services.

24. Many policy advocates champion the creation of a more diversified economy, and one that is less reliant on Wall Street. What is your position on such a plan? If you support it, what would you do to diversify the city's economy? How would you adjust spending in New York City to accommodate the anticipated reduction in tax revenue as the tax base shifts to lower paying jobs?

I will continue to fight hard for the creation of green jobs in NYC, which will expand employment options for all income brackets.

25. What would you propose the Department of Education do to increase the ability for parents and teachers to become more meaningfully involved in the education system? What other positives changes can be made to the New York City public school system?

As a parent of 2 girls in public schools, I support more parental involvement, which would include truly independent parent coordinators. I also support Mayoral control.

26. What would you propose to increase the transparency of the Board of Elections in the City of New York's operations and accountability to the city and its voters?

I am presently introducing a Resolution calling for reform of the entire petitioning process.

27. What would you propose to further enhance transparency regarding the relationships between council members, their families, and nonprofits that receive funding from New York City?

I introduced a resolution to amend the Council Rules that will ban contributions from Council Members to groups employing family or staff.

VALLONE OP-ED ON SUPPORT OF EXTENDING TERM LIMITS

After much deliberation, I cast my vote to extend term limits for city office holders from two to three. This is one of the most difficult decisions I've ever had to make. There are good people and good policies on either side of this issue. I have carefully considered both the pros and cons, weighing every opinion I've heard.

At its core, this is a debate between the practical application of our government and the Democratic ideals that are its foundation. While I believe, and most people agree, that a referendum on Election Day would have been the best way to alter term limits, at this point it is not feasible. A special election would not only cost \$15 million, but also take at least 6 months to go through the charter revision process culminating in approval by the Justice Department. With the change in the presidential Administration, federal agencies will not even be staffed until February, likely pushing a ruling on an election into the summer. This uncertainty would cause government paralysis during these trying times.

The question then becomes, should the infeasibility of a special election preclude leaders from making a huge improvement in government by altering, not overturning, the result of a flawed referendum? While most voters may not appreciate the problem with a two term limit, I must stress how severely it handicaps the legislature as a counterweight to the mayor and as an efficient governing body. No government expert I heard in over 20 hours of hearings believed that two terms is better than three (and most believe that none is better than three). When my father was Speaker, he stopped Rudy Guiliani from moving Yankee Stadium from The Bronx to Manhattan. Today, with the Speaker either a freshman or a lame duck, such opposition would be impossible. In addition, as it takes many years to plan and to complete a capital project—such as a park or ball field, bridge or tunnel—two terms hurts improvements to local neighborhoods and city infrastructure.

I understand and respect the argument that elected officials should respect the will of the voters, but those same voters elected me to act in the city's best interests. It is easy to make grandiose speeches about democratic ideals, citing flowery quotes from history. It is much harder to do the responsible thing and to make controversial decisions about the nuts and bolts of civic policy. At this moment in time, during this crisis, I believe it is far better to allow voters to choose experienced government officials at the polls than denv

them that choice. If they disagree with me, and I'm sure many will, they will have their own referendum on my decision at the polls next year.

For the record, this is not a decision I wanted to make, but one that was thrust upon me. My decision is not politically expedient for me. Now that this vote has passed, I have closed the door to a borough-wide office that I believe was a very good possibility. I did not make this decision because of how it affected me personally or any other individual, but I based it on what I felt was best for all people in the city.

As the political grandstanders move on to look for their next 15 minutes of fame, I hope we can focus on a respectful discourse between the good people on both sides of this issue and start to turn our attention to the serious business of running New York City now better armed to deal with the trying times ahead.

Council Member Peter F. Vallone Jr. Bio (2009)

Council Member Peter F. Vallone Jr. represents Astoria and the surrounding communities in the New York City Council and serves as Chair of the Public Safety Committee. As Chair, he has led the fight to stop cuts to the NYPD and put more officers in our local precincts. He has introduced legislation to keep illegal guns off the streets and out of the hands of domestic violence offenders; to abolish the statute of limitations on child abuse offenders and rapists; and to make our anti-graffiti laws the toughest in the country. Vallone is leading the fight to get New York City the money it deserves from the state and federal governments so that New Yorkers will continue to be protected from criminals and terrorists.

As an Assistant District Attorney with the Manhattan District Attorney's office for over six years, Vallone successfully prosecuted various street crime matters and compiled an impressive trial record of 40 top count convictions against one acquittal.

As the father of two girls attending public school, he knows firsthand how important it is that every child has a **safe learning environment**. He wrote the law that **put security cameras in all New York City public schools**. He is a sponsor of legislation which would require the New York City Department of Education to provide security measures for nonpublic schools, which would **allow schoolchildren to carry cellular phones to and from school for safety purposes**. In addition to safety, he has given **millions of dollars** to local schools **to improve facilities**, **install computers and ensure that afterschool programming** serves the children.

Dubbed, 'The Man Who Hates Graffiti,' by the New York Times and 'Graffiti Public Enemy No. 1' by the Staten Island Advance, Vallone has waged a war against graffiti vandals. Recognized around the world as an anti-graffiti crusader, Vallone's legislation has made it illegal to sell graffiti tools to minors and imposed a requirement that affects larger buildings and stores to clean graffiti from their property. Most recently, the Council overwhelmingly passed Vallone's bill restricting the sale of etching acid. As the NYT recently said, "Mr. Vallone might be to graffiti what Mayor Rudolph W. Giuliani was to squeegee men."

He has been honored for his work to protect our most vulnerable, which includes awards from the Council of Senior Centers and Services of New York City, the Immaculate Conception Youth Program (ICYP), the League of Humane Voters, and countless other organizations.

As Pro Bono Counsel to C.H.O.K.E. (Coalition Helping Organize a Kleaner Environment), Vallone led the fight against the proliferation of power plants and represented C.H.O.K.E. and Astoria residents in court, winning a major victory against the New York Power Authority that lead to the closing of the Charles Poletti Power Plant in 2010, the worst polluter in the city. Vallone also wrote the landmark Plastic Bag Recycling Act, which established film and plastic bag recycling in New York City.

Vallone has been remarkably successful in bringing back resources and funding to the community because of the respect he has generated from his colleagues and peers.

An accomplished athlete, Vallone was invited to play against the Chinese National Ping-Pong team on ABC's Wide World of Sports, was Co-Captain of the Astoria Civic City Champion Football and Softball teams and continues to play as much indoor and beach volleyball as his busy schedule permits. He is also a professional musician, playing four instruments and an avid scuba diver. Vallone was born and raised in Astoria, Queens. He graduated *magna cum laude* and Phi Beta Kappa from Fordham College and from Fordham Law School. He has two daughters, Catherine and Caroline.
