

Additionally, city employees and retirees contribute to the city's economy and are vital to the provision of city services.

I believe the City should have further authority over rent regulations and tax policy.

20. Taking into consideration the lessons learned from the debates surrounding congestion pricing and the Ravitch Commission's recommendations to provide the MTA with long-term funding, what would you propose to address the MTA's fiscal solvency issues and ensure that the burden for funding the MTA is equitably distributed among all stakeholders?

I support the Ravitch Commission's recommendation to impose a payroll tax, as well as the reinstatement of the commuter tax with a portion designated to fund the MTA.

21. What would you propose in terms of creating a greater role for the city council in determining and deciding the city hadget?

I propose the Council be allocated enough resources to increase the ability of the Finance Division to act as a counter balance to the Mayor's Office of Management and Budget, which has a far larger staff and that the Council be granted increased information regarding agency budgets.

22. What is your position regarding the City's past practice of using surplus tax revenues to pay down future health cost and pension obligations, and the decision not to do so this year?

I believe the City's judget should be balanced to avoid putting costs off into the future, but believe the city should use surplus tax revenues to pay down these costs.

23. What is your view of how the taxes paid by New Yorkers compare to the value that is received in City services? Do you believe that taxes should be raised or lowered? To the extent you believe taxes should be changed, please provide specific proposals about what taxes you would raise and what services you would cut, if you didn't raise taxes, listed in order of greatest magnitude.

I would focus of revenue raising proposals that do not unduly burden low income households and working New Yorkers, such as reasonable concessions in parklands. I support a review of the city's Personal Income Tax to make it more progressive and to shift the burden off working New Yorkers. I also support the reinstatement of a progressive commuter tax to make sure that those benefiting from the hard work of New York's civil servants pay their fair share.

24. Many policy advotates champion the creation of a more diversified economy, and one that is less reliant on Wall Street. What is your position on such a plan? If you support it, what would you do to diversify the city's economy? How would you adjust spending in New York City to accommodate the anticipated reduction in tax revenue as the tax base shifts to lower paying jobs?

The city's reliance on Wall Street is inevitable, though small businesses are a vital part of the economy and I believe we need to enact policies to support local employers. Wall Street does need increased regulation, as has been seen through the recent economic crisis, though must be allowed to recover and profit again. Additionally the city should continue to work to increase tourism and assist our small businesses so that they may grow and prosper.

25. What would you propose the Department of Education do to increase the ability for parents and teachers to become more meaningfully involved in the education system? What other positives changes can be made to the New York City public school system?

I believe charter school parents should be able to serve on Community Education Councils and in an increase to the Teacher's Choice program to enhance the dedication and enthusiasm of all teachers.

26. What would you propose to increase the transparency of the Board of Elections in the City of New York's operations and accountability to the city and its voters?

I believe the Board should increase transparency by increasing the amount of information available via the internet regarding elections and candidates.

27. What would you propose to further enhance transparency regarding the relationships between council members, incir families, and nonprofits that receive funding from New York City?

I believe the recent campaign finance legislation and city rules carried out by the Campaign Finance Board and the Conflicts of Interest Board provide a clear map to enhance transparency and applied illegalities and appearances of impropriety.
