

## Council Member James S. Oddo Citizens Union Questionnaire

14. I voted against the term limits extension law in October 2008. Although, as a general rule, I believe a 12 year term limit for Council Members is a better policy than 8 years, I opposed the manner in which the Council changed the law through the legislative process. I believe the law should have been changed through a voter referendum because the underlying term limits law was enacted into law in that way.

18a. To address the growing pension costs I would encourage the city to negotiate with the municipal unions to determine, through the collective bargaining process, what steps could be taken to reduce some of the pension costs borne by the city. The negotiating table is the proper forum to consider health insurance costs and the Tier V issue.

19a. I support former Mayor Giuliani's call for a State Constitutional Convention. The three most important areas are: (1) Addressing the succession issue with respect to the office of Lieutenant Governor; (2) exploring the idea of requiring a supermajority for tax increases; and (3) examining the state budget process.

19b. As a general rule, greater home rule should not be granted at this time because of the current makeup of the City Council. Since the body generally has a progressive bent and there is not a great diversity of political opinion, further home rule would most likely make it easier to raise taxes and spend more tax payer money.

- 20. I represent part of Staten Island and a portion of Brooklyn. My district is separated by the Verrazano Narrows Bridge, a span whose toll was just raised to an incredible \$11. The people of my district understand the inequitable distribution of resources. I believe we should examine different options such as the commuter tax and treating the people of all boroughs equally by examining the tolling of the East River Bridges. This seems more equitable than the efforts to continually raise the Verrazano Bridge toll to astronomical levels.
- 21. Better and truer oversight of agencies and an even more thorough analysis of OMB's work can only come through a more balanced playing field. Currently, Council staff is asked, in effect, to go "toe to toe" with OMB despite being outgunned badly in terms of personnel and resources. That should change to give the Council a greater role in the budget process.
- 22. I support efforts to prepare for the future during the years of surpluses with the caveat that there should be a means of accessing those funds during fiscal crises. Unfortunately, those years with surpluses will not be repeated any time soon.

- 23. My constituents do not receive sufficient services when compared to the taxes they currently pay. In the wake of 2003's historic 18.5% property tax increase and the rapid increase in assessed values, some of my constituents are paying 50, 60, 70% or more in higher property taxes than they were a few years ago. Middle-class New Yorkers pay too much in property taxes and they should be lowered. Billed as a "temporary war time tax" when first proposed, they have been anything but temporary. We should find savings by helping to tame the Medicaid monster and cutting down on the fraud that still exists.
- 24. Many respected pundits believe that the Wall Street we once knew will never come back. Thus, I support the idea of diversifying our economy. We must particularly examine ways of becoming friendlier to small businesses by loosening the regulatory chokehold that stifles so many of our small businesses. That is why I worked with the Bloomberg Administration and introduced and was the lead sponsor of legislation creating a Regulatory Review Panel to review the labyrinth of regulations that our small businesses must deal with on a daily basis. This panel will help diversify our economy by making New York City a more small business friendly place. I also supported Speaker Christine Quinn's proposal to switch to a single sales factor, which will encourage business to create jobs in New York.
- 25. I support Mayoral control of our school system. I would like to see the system continued. To answer the question in a word: superintendents. Empower them. In a somewhat related matter, I believe the DOE, through its 5 year capital plan, punishes those schools and boroughs that do not allow their schools to enter into a state of disrepair by sending fewer resources to those areas. I have seen it in Staten Island where we are, in effect, punished with fewer resources for not letting our schools deteriorate. DOE should ensure that a minimum amount of resources are expended in all 5 boroughs to ensure some level of equity.
- 26. Take the politics out. The Mayor has talked about for a while now, but it finally needs to be done. A system based on competence and talent, not patronage. What a concept. In the interim, if the current system stays in place, I would be amenable to opening up the Board of Elections to members of parties other than Democrats and Republicans. The reality is that many New Yorkers are affiliated with third parties or not affiliated with any party.
- 27. More work need to be done.

## Candidate Accountability Questionnaire

Top five campaign promises from 2005 and action on them

- 1. <u>Promise</u>: Pass legislation to institute a system of licensing for one, two, and three family home builders. <u>Progress</u>: This legislation was passed by the City Council and signed into law by the Mayor in the summer of 2007.
- 2. <u>Promise</u>: Bring quality and affordable senior housing to Staten Island. <u>Progress</u>: Secured \$6 million for Park Lane at Sea View senior housing project, which rehabilitated the old Nurse's Residence on the Sea View Hospital campus for desperately needed affordable senior housing on Staten Island. The ribbon cutting and grand opening was held in June 2009.
- 3. <u>Promise</u>: Work with DOT to identify and improve Staten Island intersections as a way of improving traffic flow, one intersection at a time. <u>Progress</u>: This approach was adopted by the Mayor's Staten Island Transportation Task Force. The DOT has not been as proactive in identifying and making engineering changes at as many intersections as I hoped. I continue to work with DOT identifying and making suggestions as to intersections that can be improved.
- 4. Promise: Help bring about better health care services on Staten Island. Progress: Allocated almost \$3 million in capital funding to help Staten Island University Hospital build its new state of the art Emergency Room. The new Emergency Room opened its doors in June 2009, We still have work to do to get the Bloomberg Administration to live up to the city's health care responsibility to this borough.
- 5. <u>Promise</u>: Continue progress on the New Creek and Richmond Creek Bluebelts to help alleviate certain flooding conditions in various Staten Island neighborhoods. <u>Progress</u>: Necessary property acquisitions continue and the appropriate site stabilization work is ongoing. I recently allocated \$500,000 to allow for the dredging of the West Branch of New Creek, which will provide a modicum of immediate flood relief and will be part of the long term Bluebelt system.

I think it is refreshing to indicate a promise that, to date, we have not brought to fruition, and that is the transformation of the Farm Colony property into something that will make us all proud. We came so close to having a proprietary secondary educational institution take the entire campus, only for that deal to collapse. Our work with Dr. Michael Tomlan of Cornell University, with former LPC Chair Jennifer Raab, with noted preservationist and architect Paige Cowley, has proven that this endeavor, although far from complete, is indeed worth the struggle. We will continue to work at finding an acceptable use for the property.

# Top 5 2009 Campaign Promises

- 1. Bring additional affordable senior housing units to fruition Staten Island
- 2. Ensure that the Department of Education purchases the old Doctor's Hospital site for use as a school to alleviate overcrowding at PS 48 and other local schools.
- 3. Work to bring city agency operations and more businesses to Staten Island as a means of improving our local economy.
- 4. Work with the local medical community on Staten Island to convince the Bloomberg Administration to help provide capital for our medical institutions.
- 5. Ensure that DOT has the necessary resources to resurface our crumbling roads.
