- 13. I oppose the use of matching funds because this has generated a lot of waste and driven up the cost of local elections in New York City. Candidates with no prospects of ever winning an election get thousands of taxpayer dollars to hire friends and family members. Full public financing could help to limit the growth in spending on local elections and permit better regulation of the use of campaign funds.
- 25. I have no position on this because it could result in another duplicative government office. We have the New York State Division of the Budget, which could be required to produce what the independent budget office is charged with in that proposal. On the other hand, if reformers feel that the Division of the Budget is not accountable to the public, why not require by statute that it be made accountable to the public instead of creating yet another government office.
- 29. Performance budgeting and outcome measurement are not objective tools and can be politically manipulated, as evidenced by controversies regarding the rise in New York State standardized test scores and New York City's graduation rate. There is no one method for governance that is accountable and transparent to voters; that will work forever; and, that is not subject to political manipulation. Democracy is not an autopilot system or some kind of remote-controlled system set up by elites that works perfectly regardless of who is in office. Sometimes things get messy.
- 30. It is not clear to me that changing the start of the state's fiscal year will improve its financial condition or financial management.
- 31. It is not clear to me that using conference committees will ensure an on-time and balanced budget in New York State. I would like to learn more about this proposal.
- 32. Requiring judges to be appointed as opposed to screened and then elected reduces voter participation in the Democratic process. I have enjoyed meeting judicial candidates campaigning because it gave me a chance to talk to them and to find out more about them and their political identities.

TOP FIVE 2010 CAMPAIGN PROMISES OR GOALS

1. I will fight to preserve and expand affordable housing, including home ownership opportunities for low

and middle income residents.

. I will fight to expand child care throughout the state, including building a coalition to advocate for

universal publicly funded child care, regardless of family income. Fostering broad participation in a

universal child care system is the only way to ensure that child care becomes a protected public good. If

we seek only to provide subsidies for low income families, child care is vulnerable to budget cuts and

political attacks.

3. I will seek to create jobs by engaging unions and businesses to hear their ideas and preferences, and by

supporting or proposing legislation that promotes developing industries, such as renewable energy or that

reforms corporations, such as proposals to reform Industrial Development Agencies that give public

subsidies and tax incentives to private corporations that then do not create jobs for local residents.

I will be an advocate for campaign finance reform, with full public funding of state elections.

5. I will push for tax reform in order to more fairly distribute the responsibility to fund public services

among the high income taxpayers, and lift some of the burden off moderate and low income taxpayers.
