### TOP FIVE CAMPAIGN PROMISES OR GOALS FROM 2008 AND ACTION ON THEM

- 1. Reform: In 2010, we successfully passed landmark ethics legislation that ends the era of secrecy and significantly raises the bar of disclosure and accountability for elected officials. Additionally, I am a cosponsor of Assembly Member Gianaris' independent redistricting bill, as well as the stricter campaign finance laws.
- 2. Environment: As Chair of the Subcommittee on Renewable Energy, I was a co-sponsor of the Green Jobs/Green New York Program that passed the Legislature last year. This legislation encourages conservation, helps consumers with the cost of sustainable improvements to the homes and will save billions in energy costs. Additionally, I have been working to reduce the effects of waste removal trains that travel through much of my district, emitting harmful emissions and polluting the area.
- 3. Improving the Quality of Life: I have recently introduced four bills that address the major problems caused the transfer of waste by rail in my district. As a result of the railway tracks and their cargo, a multitude of environmental and health concerns have occurred including noise problems at all hours, odor and pest issues, and air pollution. In a neighborhood where asthma rates are on the rise, and where families seek to raise their families in safety, addressing this issue immediately is of great concern to me.
- 4. Create New Jobs: The Green Jobs/Green New York Program is a vital step toward improving our economy, with the creation of thousands of jobs to update our aging infrastructure. The program will create workforce training programs throughout the state to ensure that the state's workforce is highly trained and in place to handle mass-scale retrofitting.
- 5. Education: I supported the landmark charter school bill that increased accountability for charter schools while qualifying New York for vital Race to the Top funding, as well as the expansion of parental involvement in the recent extension of mayoral control last fall. In 2008, after working with local parents and teachers, I provided a grant for IS/PS 87 to restore Fast for Word, a computer-based program designed to help children with learning disabilities improve their reading skills. In addition, I have worked to restore funding for various youth job programs.

#### TOP FIVE 2010 CAMPAIGN PROMISES OR GOALS

- 1. Improving the Quality of Life: I am committed to continuing the fight to eradicate the problems that are caused by the garbage trains. In addition, through my legislative email program, I will continue to work one on one with my constituents to address problems as they arise.
- 2. Updating our Energy Infrastructure: I am committed moving both our state's energy structure and economy into the 21st century through the promotion of green projects. I have just introduced a legislation to create a viable competitive market based system for the installation and generation of renewable energy in New York. I also believe that we need to invest in smart grid technology in order to upgrade our energy infrastructure in New York. As we've seen with power outages in the past—few weeks, updating our power grid to reflect modern energy needs. In addition, promoting smart growth projects, which redevelop current infrastructure, allow for greater community planning and minimize sprawl by utilizing existing infrastructure.
- 3. Restoring Medicaid Funding: Medicaid funding has been slashed, resulting in cuts to dental and vision programs, as well as cuts to basic care. With the historic health care reform in Washington that passed this year, we must ensure that New Yorkers are receiving the best quality care possible. Restoring Medicaid funding to levels that allow for quality, comprehensive preventative care is key to making

- healthcare affordable for all New Yorkers.
- 4. Restoring the Education Budget: Nothing is more important to the future of our state than fully funding our state's education system. Cuts to education means less teachers, larger classes, and less specialized classes like art and music. We need to ensure that our education budget is restored, and that we are adding funding for English language learners and special needs students.
- 5. Creating New Jobs: We need additional program and incentives to create new, middle class jobs that will move our state's economy into the future. Our state needs to identify developing industries, such as renewable energy, and incentivize them here in New York.
