TOP FIVE 2010 CAMPAIGN PROMISES OR GOALS

- 1. Education is a major priority for me, as I have seen the dire effects that budget cuts have on our schools, our teachers and our students. Rising class sizes, a reduction in arts funding and more relaxes security lead to a disruptive learning environment for all students. We should be striving to fund education to the highest levels.
- 2. We should be incentivizing new, good paying jobs by attracting 21st century projects to our state. In addition to providing new middle class jobs that will stimulate our state's economy, generating projects that modernize our state's infrastructure and energy systems will help to move our state into the future.
- 3. We should be addressing public transportation in our city. The Second Ave Subway line has been delayed yet again, while construction reeks havoc on the lives of those in my community, and the MTA is proposing new fare hikes for the second time in less than a year. We need to get the MTA's budget crisis under control and ensure that capital projects are on time and don't completely disrupt the lifestyle of an entire neighborhood. Middle class families depend on trains and buses to move around the city, and should not be penalized by the MTA's mismanagement.
- 4. We need to work to protect affordable housing by repealing vacancy decontrol, prohibit landlords of rentstabilized buildings from unfairly increasing rents under the "unique or peculiar circumstances" loophole, and work to repeal the Urdstadt law.
- 5. Above all else, we need to fix the culture in Albany that has allowed our state's fiscal crisis to manifest to this point. Their inability to pass the simplest legislation is appalling. After three months, we still don't have a budget. State lawmakers have lost sight of their obligation to everyday New Yorkers. We need real leaders in Albany, who will fight for working men and women and won't balance the budget on the backs of the middle class. With your support, I will be an unwavering advocate for workers, and will fight to make Albany fight for the people.
