As it relates to question 2 under campaign reform, I understand the concerns with the two-party system and agree with many of the goals of Citizens Union to ensure that the "duopolistic" nature of the party system is dismantled. This is one of the reasons why I proudly sought and received the endorsement of the Working Families Party, and why I have supported candidates running on the WFP line. It has inserted "competition" into the party system in New York, and I think it has given progressive candidates such as myself the opportunity to win elections.

The problem I have with doing away with partisan elections is that, for better or for worse, is that right now, political parties are the only way to mobilize voters who do not have the resources to mobilize themselves. The citizens I represent in the Bronx, who do not have the time or money to become involved in politics, would be hurt by nonpartisan elections. Absent campaign finance reform and the FULL public financing of campaigns, it would further lead to wealthy individuals influencing campaigns. It is unconscionable to me, for instance, that an individual can spend nearly a quarter billion dollars of his own money to win election for mayor three times. Non partisan elections would do nothing to curb that problem, and would do nothing to mobilize the poorest voters to exercise their constitutional right to vote.

TOP FIVE CAMPAIGN PROMISES FROM 2010 AND ACTION ON THEM

In 2010, I made five "commitments" rather than promises, which I have upheld to the best of my ability. They are in order, and ways I have upheld them.

1. Commitment to my constituents – the first commitment I made is to serve my constituents to the best of my ability. That begins with living in the district, as I have done for the last ten years in a rent stabilized apartment. I am committed to providing the best constituent service to my community through my legislative and district offices by helping them navigate the red tape of city, state and national government. I've done this work as the Chief of Staff for State Senator Andrea Stewart Cousins and as the State Director of Outreach for US Senator Kirsten Gilibrand.

I have upheld this commitment by serving the residents of the 33rd District with a tireless staff that has provided the highest quality constituent service. We have been successful in cutting through the red tape of government bureaucracy to assist Bronxites and provide them with solutions to problems. I did move after being elected, but I moved to an apartment across the hall in the same rent stabilized building. I continue to walk to my District Office, which is 10 minutes away. Walking around the district and interacting with folks on the street is an important way for them to know they have access to me.

2. Commitment to be a full-time legislator – I believe that the NY State legislature should be a full-time job, and I will make a commitment to treat it as such until the laws are changed. Taking employment elsewhere can give the appearance of serving two masters, when the only master a legislator should serve is his constituency.

The only "outside" job I've taken is one I've held for years – as an adjunct professor at Pace University. I teach one class in the fall semester, which meets one night a week. I am compensated roughly \$3,000 for my teaching. All of my time outside of that 1 course is dedicated to serving the residents of the 33rd district and the State of New York. Regardless of whether I am in legislative session or in the district, I work for my constituents every day of the week.

3. Commitment to good government – I will uphold the principles outlined here because I believe firmly that good government means sound public policy. This is what I've taught to my students for the last 11 years, and the last 10 as a faculty member for Somos EI Futuro – the Model State Senate sponsored by CUNY and the Latino Task Force. Accountability, transparency, and reform will be hallmarks of my Senate career.

The first bill I introduced was part of an ethics package that mandated full disclosure of all outside sources of income for legislators. I have sponsored and co-sponsored other legislation committed to good government including many of the issues mentioned above like public campaign financing and banning lobbyists convicted of a felony from lobbying legislators for a period of time.

4. Commitment to civic literacy, participation and engagement amongst our youth - as an educator, I believe elected officials need to do all they can to educate the public. I've done this for more than a decade through programs I've been part of at Hunter College, Pace, and through the Justice Resource Center at MLK High school. I am committed to using my office to foster civic competency amongst our youth by bringing innovative programs to the schools in my district and throughout the city.

One of the initiatives we launched in the fall of 2011 was a series of civic literacy courses I taught at a few public libraries in my district, which were free and open to the public. The program consisted of four lectures on the American and New York government including: the U.S. Constitution, the Bill of Rights, Voting and Elections, and NY State government. The classes were offered in English and Spanish, and I am proud to say hundreds of community members and young people attended the lectures.

In 2011, I worked with community partners to launch the Bronx CAN Health Initiative (Changing Attitudes Now) which sought to assist individuals – especially youth – in taking ownership of their health. We held health fairs and exercise classes for our residents, as well as educational programs on how to live healthy. I am currently in year two of the Bronx CAN Health Initiative and have introduced several pieces of legislation that came out of conversations with community members and health organizations on issues of health. I am particularly proud to have passed legislation this year through both the State Senate and Assembly to ban smoking within 100 feet of school entrances and exits.

Senator dedicated to creating opportunities for them that allows them to fulfill their potential. This means: job creation and responsible economic development; tenants rights and affordable housing through the reform of our housing laws; education reform that gives all of our children stellar educational experience; and promoting healthcare so individuals can be productive members of society. I am committed to enacting all of these progressive policies.

I have made good on my commitment to these policies. I supported the continuation and strengthening of rent regulation laws; the creation of regional economic development councils which have already assisted the Bronx; the creation of the statewide health exchange; as well as more funding for education – to name a few.

TOP FIVE 2012 CAMPAIGN PROMISES OR GOALS

- 1. Public Safety in the 33rd District we have to do all we can to get illegal guns off the street and stop the gun violence, while also ensuring that community members feel the police is there to protect them and their families. That means doing away with programs like Stop and Frisk, which I believe is unconstitutional, and it means ensuring that immigrants in the Bronx are not afraid to approach law enforcement for fear of getting caught up in deportation proceedings.
- Criminal Justice Reform as the Ranking Member on the Crimes, Crime Victims, and Corrections
 Committee, it is my job to help oversee the corrections system, to ensure victims are protected, help
 those who have been wrongfully accused, and to give those returning from prison the opportunities they
 need to be productive citizens.
- 3. Community and Economic Development While unemployment has decreased in the Bronx, it is still the highest in the city and near the highest in the state. We need to do more to promote responsible economic and community development. I support the governor's efforts to invest hundreds of millions of

- dollars in the Regional Economic Councils and think we can do more. At the center of that effort in my district is the redevelopment of the Kingsbridge Armory, which has the potential to revitalize my neighborhood and provide hundreds of living wage jobs for my neighbors.
- 4. Health Care the Bronx continues to be the unhealthiest county in the State. This is why I launched the Bronx CAN health initiative and will continue to work with community partners like Montefiore Medical Center and Bronx Health Reach to ensure that my community gets access to healthy foods, preventative care, and the best possible health coverage we can provide. As a member of the Health Committee in the State Senate, I will continue to propose legislation that will improve the health of the Bronxites I serve.
- 5. Education I continue to be an educator and believe it is still the Great Equalizer in our society. It is the main engine of upward mobility, especially in a District such as mine which has higher levels of poverty and lower high school graduation rates than just about anywhere in the state. Education is important for everyone but it is more vital in my community than ever. I will continue to work on educating our youth, reforming the education system in terms of curriculum, and providing our teachers the resources they need to do their jobs to the best of their abilities.
