The election process is the cornerstone of a functional and equitable democracy. In March of 2011, I voted to pass a resolution (S 3331 - Constitutional Amendment for Non-Partisan Redistricting Commission) that submits a constitutional amendment to the voters to create a non-partisan redistricting committee which prohibits any district from having more than a 5% difference in population from any other like district. This also would prohibit dilution of any voter base for political agenda. I also voted "yea" on A 9544 - Election and Campaign Finance Ethics Amendments which overrides disenfranchising past laws and establishes a series of ethics committees and strategies for oversight.

With respect to the Judicial system, I have a longstanding record of modernization. I have voted in favor of expansion of modern methods in the justice process and hold the belief that progress is necessary for any improvements of flawed systems. Furthermore, people with legal and political power or clout must be placed or elected into those positions by the work they have done and the work they will do in the future. I voted to expel Hiram Monserate from the senate which is in synch with my belief that there is a responsibility of clouted and powerful people to be married to their mandates and uphold the law in addition to bolstering process.

Every vote I have ever made regarding the budget has been in favor of transparency and the preservation of the funds for citizens' retirements as well as to alleviate tax burden on the struggling middle class of NYS. I voted to protect pensions, increase aid to those who are struggling, and to require a ¾ majority vote to change tax rates.

As a legislator, I believe in equity. I preserved district size equality so that no group overpowers another. Progress is my goal as a legislator and my goal for New York.
