As a NYC Emergency Medical Technician, at age 19, I learned what it meant to be trusted with a life, as a Community Police Officer in the Bronx I learned the value of promoting quality of life while serving with honesty. Criminals who tried to bribe me were arrested, by me, and prosecuted for the attempted corruption of my public service. I received two integrity awards for such. As a Lieutenant Commander in the US Coast Guard reserve, the past 24 yeas of service, have also reinforced that my word is my bond. I have been trusted with millions of dollars worth of assets at various times without question or any issue of integrity. Integrity is the hallmark of who I am. It is time that we improved the image of our representation in Albany. I have a small law practice and

can support myself without political office. Integrity is something that cannot be taken it must be given. I have always chosen not to give or sell mine and will continue to do so.

Redistricting reform must occur. The concept that would be my priority is protecting neighborhoods. Making certain that similar interests have a voice that is undiluted. Marble Hill in my neighborhood is a good example. 11 housing project buildings 7 in Manhattan district 4 in the Bronx (all physically within the confines of the Bronx). This community would be better served by being in the same districts. The issues of one building affect the building 30 feet away.

Laws should be in place to increase voter participation. Easier registration will enable people to get involved immediately. This will engender greater participation. Ethics rules must be enforced in a fair and open manner. We must treat all people fairly. Keeping in mind that we must open and encourage more people to run for office. The process must not be one where one should be made to feel that one must be attacked in order to run. This also causes apathy in the community, something we should strive to avoid.
