Many New Yorkers struggle to get to the polls on Election Day. Sometimes, this is an accessibility issue (voters who are elderly, disabled, chronically ill, or caring for young children face extra challenges in getting to their polling places). In many cases, work schedules conflict with voting hours, which puts wage workers at a disadvantage because they may be forced to choose between voting and earning money. Regardless of the cause, expanding access to early voting (3a) and implementing no-excuse absentee voting (3b) helps

address these issues and ensure that people remain fully franchised whatever their life circumstances.
People on parole should automatically be re-enfranchised without the need for a Certificate of Good Conduct (3d
People on parole face many challenges reintegrating themselves into society, and cutting them off from
participating in their democracy exacerbates that struggle. A system that continues to push people out of society
rather than allowing them to fully rejoin once they have served their time harms the health of our democracy
as a whole, and perpetual loss of franchise is an unfair way to punish people's mistakes. Enjoying the full
privileges of citizenship should not be conditional on compliance with certain definitions of good conduct.

Past Campaign Promises: Extended Info

- 1. As a New York City resident, I am unfortunately familiar with the shortcomings of our public transportation. With an annual ridership of over 2.6 billion, fixing the MTA is crucial to help the city and state keep moving forward. This project was and remains one of my top priorities. So far, much of my work on this issue as an assemblyman has focused on ensuring that people have their voices heard and advocating for improvements. In May, just a few days after my inauguration, I hosted a press conference advocating for handicap accessibility on the L train and throughout the MTA subway system. I look forward to future opportunities to improve the system, both through legislation and through advocacy.
- 2. I have spent almost my entire career advocating for fair housing policies and tenant rights. My top priority upon taking office was to alleviate the New York City housing crisis. While this is an enormous issue that will take consistent, sustained effort to solve, I am proud of the actions I have taken to address the problem so far. I cosponsored the Assembly bill to repeal vacancy deregulation (A09815), which is currently awaiting Senate action. I also sponsored bills to ensure that landlords would face financial consequences for providing substandard conditions (A1065), including lack of heat in winter months (A11083) and limited landlord ability to increase rents (A11104) and charge high application fees (A11076). I am working to ensure that NYCHA housing is held to a higher standard and to help people who have been hurt by substandard housing, most notably through my work on establishing NYCHA health centers that provide residents basic services and specialty care for mold exposure, lead poisoning, and respiratory illnesses (A10887). I also recently introduced a bill to establish an office of the cooperative and condominium ombudsman (A11109), and I look forward to further opportunities to chip away at the crisis and ensure that New Yorkers are guaranteed safe and fair housing for generations to come.
- 3. The criminal justice system often fails to provide equal treatment, biased by race and class. Reforming the criminal justice system to improve fairness was and remains one of my top priorities. I supported legislation to help pregnant women avoid pretrial detention regardless of their ability to pay bail (A10837) and to change marijuana possession sentencing laws (A6600). I have also joined with several of my colleagues in their efforts to legalize marijuana (A3506B), which is a particularly important step to making the justice system fair because people of color tend to face harsher penalties for marijuana-related activities. I am also taking steps to protect victims of crime—from providing services such as safe housing for victims of human trafficking (A09566) to increasing penalties for companies that criminally endanger their workers (A10728).
- 4. Funding for our Public Schools in New York State has been woefully inadequate for some time. As a parent of two public school educated kids, I know firsthand how a **strong public education** levels the playing field and sets our kids up for successful

futures. The funding shortfall is unconscionable and the discrepancy between funding per student in the city and the suburbs is outrageous. In addition to securing all the funds our kids are owed, we need to continue to serve them by expanding Pre-K programs, after-school programs, and increasing funding for teacher professional development.

5. After decades of community organizing and housing advocacy, I am well-acquainted with the frustrations that ordinary citizens face trying to navigate an opaque government bureaucracy. One of my top priorities now that I am working within the government system is to increase transparency and citizen access. I maintain a high level of engagement in my district—it's a community that I've spent most of my life in, and making sure that my neighbors' continue to have their voices heard and amplified is one of my most important duties. I have also used legislation to ensure that citizens across the state have access to their government. I've sponsored bills to update voter registration procedures (A10842 and A10843), to help those without computers access state agency mobile websites (A10843), and to ensure that public retirement systems are transparent (A11140). I'm also committed to ensuring that people's access to services is not limited by their English ability. I have cosponsored bills to ensure that housing courts provide documents in the seven most common languages in New York City (A02890) and that civil courts provide parties with documents in their native languages (A02891).

I was raised by parents who were active union members, and participated in my first strike (supporting the teachers' union at my school) as a third grader. As an adult, I have continued to serve and lead in my community in diverse positions—from the PTA at my children's school to the Rent Guidelines Board. My career has also been centered around serving my community. After earning a law degree, I chose to focus my career on legal aid, community development, and tenants' rights rather than pursuing a more lucrative branch of law. In following this path for over twenty years, I feel that I have demonstrated that I value contributing to my community and elevating the voices of the vulnerable over personal gain. In this office, I am committed to maintaining this pattern. Many of my constituents deal with substandard housing conditions, and my primary motivation in seeking office was to be able to enact regulatory legislation that would ensure that housing conditions improve. I cannot do my job effectively if I am not in regular contact with my constituents, and I host local events regularly to give people the chance to make their voices heard. I have lived and worked in my district for decades. My children grew up here and many of my constituents knew me well long before I sought office. I am proud to be a member of this community, and I have worked hard to bring the spirit of community organizing to the 74th State Assembly office, engaging constituents to get involved in local policymaking. By maintaining strong relationships with the folks I live and work with, I believe my community will hold me accountable and ensure I honor the trust and responsibilities of this office.

State Assembly Member Harvey Epstein New York's 74th Assembly District

With a landslide victory in the April 24th special election, our district voted to send a new voice to Albany.
