I am a big believer in accountability, transparency and the power of the people. If a party vetoes an investigation; that usually means that there is something that is being hidden. This cannot be allowed to continue. Investigations are to happen uninterrupted and without bias. Whatever decisions are made, must be public knowledge to increase transparency.

I am a huge supporter of voter and election reform. Voter turn-out is usually low due to many things such as; disenfranchised voters, limited access to poll centers, multiple primary dates that cause confusion amongst the voters and so on. Many voters are not able to get off work

during the election dates and early voting would be very convenient for them. As far as the electronic poll book goes, it can be very convenient. Each state has their own use for them. I would still like to see the poll workers have paper books as a back-up, but the electronic poll book should be used for the main purpose of speeding up the check in process. No background checks into voting history or facial recognition or ID requirement. I have pushed for this these reforms through petitions and just talking about it at forums and advocating for it at actions.

When it comes to campaign finance, I definitely support closing the LLC loophole. Many corporations have various LLCs that are either affiliated or actually owned by them. These are ways that they are able to fund certain candidates who are willing participants in the pay to play scheme. The same goes with reducing campaign contribution limits of lobbyists. There are too many candidates who are willing to Side with lobbyists and their special interests instead of the people and that is unacceptable.

On the subject of police accountability, I am the leader of the Brooklyn sector of Copwatch Patrol unit. We are a grassroots organization on the frontlines of the fight for police accountability. I have also supported and have participated in actions with End Broken Windows Coalition and others, calling for the repeal of 50-a. 50-a blocks the transparency that is needed.

On many of these issues, I am looking into introducing and Co-sponsoring legislation to bring about the true reform and changes that we need.
