I wish to elaborate on my positions concerning Early Voting and same day voter registration. While I believe that everyone who is legally entitled to vote should be able, given the recent performance of the Board of Elections in New York City, I am not convinced that they would be able to effectively manage the processes of Early Voting and same day voter registration. Until the Board can demonstrate that they can effectively manage the present voting system, I am not inclined to support to changes that could lead to chaos and even more mismanagement.

I oppose publicly financed elections because I believe that, in times when we make difficult choices about maintaining critical state services, we should not be using state funds for campaigns. Having been a participant in New York City's public finance program, I have come to the conclusion that the program does not accomplish its goals. It has not reduced the influence of money in politics; it has not increased competition, and it has not led to higher voter turnout. The public finance program in New York City has actually given incumbents an advantage since their challengers, because of spending limits, are often unable to mount campaigns that will allow them to overcome the advantages that incumbents have. The program has also proven to be ineffective when a participating candidate finds themselves running against wealthy self-financed candidates. While the 2001, 2005 and 2009 mayoral elections are prime examples, there have also been city council races where self-financed candidates have had an advantage.

I do support lower contribution limits, and I believe that competition for public office increases when

term limits, which I have been a supporter of for many years, are in place.

## TOP FIVE CAMPAIGN PROMISES FROM LAST ELECTION AND ACTION ON THEM

 RESPONSE TO SUPERSTORM SANDY. As you remember, Superstorm Sandy struck just days before the 2012 election. Many neighborhoods in my district were devastated by the storm.

At that point, my volunteers and I suspended the campaign to help with the recovery efforts. We helped homeowners by bringing in supplies and helping them find temporary housing. At the time, I pledged to help our neighborhoods recover from the storm.

Since that time I have continued to work with our neighbors as they continue, even today, to rebuild their lives. My office has held more than two dozen town halls in the last six yearsin the impacted neighborhoods. We brought together government agencies, non-profit organizations and the private sector to help many homeowners and businesses. Through my office, we assisted a number of residents and businesses who had difficulties navigating the bureaucracy that was put in place following the storm. We interceded with FEMA, the SBA, and an array of state and local agencies when my constituents could not obtain the assistance they were entitled to. We worked with the State Department of Financial Services when homeowners and businesses could not obtain satisfaction from their insurance companies.

- Even today, we continue to assist those who are still trying to rebuild. Most recently, on June 25, 2018, we hosted, along with NHS Brooklyn, a Homeowner Resource Event in Gerritsen Beach, one of the neighborhoods that was hardest hit by the storm. I'm proud to say that, nearly six years after this storm, my staff and I continue to stand shoulder to shoulder with those who need help.
- 2. BUILDING A STRONG ECONOMY. I promised to continue to work to make New York a place with a friendlier business climate by holding the line on taxes and spending and by working to bring more jobs to our state. In my role as Chairman of the Senate Select Committee on Science, Technology, Incubation & Entrepreneurship, I hosted a New Industry and Entrepreneurs Roundtable on the growth of the Computer and Video Game Industry in New York at Kingsborough Community College. I have supported the creation of tax credits for music and video game production throughout the state. As one of the prime movers behind the legislation that created tax incentives for the film and television industry in New York, I believe that the creation of a similar incentive program could lead to the expansion of "Silicon Alley" here in New York, creating even more jobs in what has become a booming industry here in New York, and restore New York's place as the pre-eminent location for music production.
- 3. FIGHTING CRIME. As a former New York City police officer, I understand how crime can hurt a community. In 2016, I promised to work to keep our communities safe. I continue to advocate for the restoration of the death penalty, which I believe is an effective deterrent.
- 4. TRANSPORTATION. In 2016, I promised to continue working on improvements to our mass transportation network, and I have emphasized expanding existing mass transit and creating additional transit alternatives for the residents of our city. I supported the recently enacted budget, which supports the Metropolitan Transportation Authority with a \$334 million 7 percent increase in funding over last year for a total of more than \$4.8 billion in operating assistance. This includes \$254 million to fully fund the state's half of this year's \$418 million obligation

towards the \$836 million Subway Action Plan, with New York City responsible for contributing the remaining half. As a member of the MTA's Capital Projects Review Board, I continue to advocate for the commuters of my community as we have sought to make the subway system more accessible by the construction of elevators at subway stations to make it easier for seniors and others who have difficulty walking the stairs, to make full use of the system. In May 2017, the MTA agreed to make permanent weekend express bus service on the X-28 bus line, which I had fought to restore for six years. Just last week, the MTA announced the expansion of service on the X28, X38, B1 and B63 lines, service improvements that I have been seeking for quite some time. I will continue to work with MTA officials to find ways to make our transit more efficient, safe and reliable.

5. SENIORS. I promised the seniors of my district that I would continue to work to insure that they had the chance to live their lives with independence and dignity in their community. Each year, my office conducts a number of events designed for senior citizens: senior fairs, the senior boat rides, and the "Senior Idol" contest.

## **TOP FIVE 2018 CAMPAIGN PROMISES OR GOALS**

- I will continue to stand shoulder to shoulder with the residents and businesses of our community that are still recovering from Superstorm Sandy.
- I will continue my efforts to improve mass transit, including making our mass transit system more accessible.
- 3. I will continue to work to keep our communities safe.
- 4. I will work to provide additional support to our seniors by continuing to advocate increasse in the SCRIE income limit; expansion of the Community Services for the Elderly Program, and the lowering of prescription drug prices by allowing the state

- to make bulk purchases of drugs and making those lower cost drugs available to seniors through their local pharmacies.
- 5. I will continue to work to reduce taxes for middle class New Yorkers while encouraging the creation of good-paying jobs through easing the regulatory burden on business and by offering strategic support (through grants and tax incentives) to emerging industries.
