1. serve in the Senate minority, but here are some bills that I've been working on and I think help define me as a public official:

Ethics reform - Have sponsored/co-sponsored legislation to close the LLC-loophole, limit outside income, institute campaign finance reform, prevent elected officials from using campaign funds for criminal defense

- Housing Sponsored/co-sponsored legislation to restore home rule to NYC on housing matters, end vacancy decontrol, reform MCIs, end preferential rent and more
- Environmental protection sponsor major climate change legislation in Albany (Climate & Community Protection Act), end transport of fracking waste in NY
- LGBT Rights Sponsor legislation to extend transgender rights (GENDA) end so-called gay "conversion therapy", eliminate LGBT "panic defense" to murder
- Gun law reform co-sponsor creation of extreme risk protection orders, raise age of gun ownership to 21 years, end sale of bump stocks, create more rigorous system of background checks

Citizens Union believes that all New Yorkers deserve to be represented by officials who work for the public interest and honor the public trust. With the corruption conviction of recent legislative leaders, we seek to endorse a candidate who will demonstrate that she/he will honor the full commitment of the oath of office, and always represent the public interest above all else.

Please tell us how you have and would continue to conduct the political affairs of this office in an upright manner, and maintain the public trust.

As an elected official in Albany, I believe we must address the issue of ethics reform to restore the public trust. I voted against disbanding the

Moreland Commission on public corruption, have introduced stronger sexual harassment guidelines for elected officials and immediately called for the resignation of Sheldon Silver after his arrest. Albany must be fixed!

As the chair of the Senate Democratic Conference Policy Group, I will advocate for passage of strong ethics reforms above should the Senate Democrats take control of the chamber next year, including limiting outside income and closing the LLC loophole. I believe that the state legislature should be full-time and legislators' compensation should reflect this.
