

1. What is your position on the redistricting proposition amending the constitution on the November ballot that would create an independent commission with appointees split evenly between the majority and minority parties?	Support/Oppose

TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS

1. I promised to address the lack of affordable housing in my district and held a number of in-district gatherings that attracted thousands of seniors and working families. Our office collaborated with

- advocacy groups such as Asian Americans for Equality and will continue to work with them in the future.
2. I promised to work on quality of life issues like the proliferation of airplane noise in Queens and sponsored legislation like the Part 150 bill that would require a comprehensive noise study at JFK and LaGuardia.
 3. I promised to bring more resources for our overcrowded schools and passed budgets that added more funding toward after school programs and for universal pre-Kindergarten classes.
 4. I promised to fight for social justice issues and had been a proud advocate for Women's Equality Act in the Assembly.
 5. I promised to fight for immigrant rights and had been a proud sponsor and advocate of the New York Dream Act.

Future Promises

1. I will continue to work on bringing more education resources that support passion-driven curriculum and will fight against the "teach to the test" culture in our schools.
2. I will work with my colleagues to address the lack of affordable housing for our older adults and working families.
3. I will fight for more resources, such as social space and upgraded senior centers, for our older adults.
4. I will advocate for more transparency and accountability in the state legislative and budgetary processes.
5. I will continue to explore different ways for technology to have a larger and positive impact in our state government, such as open-source codes at our agencies.
