I will also work to bring in extra monies from the federal and city governments when our community is in need. (This includes hurricane relief, school construction funding, housing funds, etc)

- 5) I work to restore voter confidence, through election reform and political action, so that the democratic process will continue to function as it was intended and so that people will have faith in the process and their elected officials. Since my first year in office I have called for an open, transparent process of elections and government.
