Frankly the list is endless about good government issues we addressed in my previous campaigns and educated the public via forums, op-eds, literature, press releases and during debates. We have been a very dynamic and robust campaign force in terms of engaging citizenry for good government.

Now we're gonna talk about the dark money and gaming the campaign finance system by skirting the law with dark money, mega-consultants and lobbyists in the Mayor's office, now our local primary for Assembly, and the WFP. We're gonna talk about the Wal-martization of and take-over of local campaigns by the WFP. We're gonna talk about the other machines hand picking their replacements – i.e. the permanent government as Jack Newfield called it a generation ago. We're gonna educate the public and we need you and other good government groups to support us in our fight about anyone or any party that skirts the campaign finance system in their power grab.

Our primary goal is to return the power and representation to the voters in this district and take it back from the super organized political machines that play loose and dangerous with the campaign finance law and dark money yet have no power to save LICH no matter their campaign promises. We say no more. What's happening to our politics is terrible and dangerous. When hospitals close, people – loved ones – die.
