Additional Information for Citizens Union - Pete Sikora for State Assembly

My advocacy and organizing career began as a canvasser for PIRG in college. After I graduated from Cornell University, I started as an organizer for NYPIRG, rising through the organization's ranks to become Organizing Director and leading their priority campaigns. At NYPIRG, I worked on a wide variety of campaigns, including support work for government reform efforts. Specifically, I worked on New York City charter revision and campaign finance reform issues with Blair Horner and Gene Russianoff. My proudest accomplishment during my seven years at NYPIRG was spearheading a coalition with then Councilmember Bill Perkins, that pushed through the Childhood Lead Poisoning Prevention Act (Local Law 1 of 2004). That legislation has saved thousands of children – primarily kids from low income communities of color – from lead poisoning, which causes brain damage and other developmental effects.

After I left NYPIRG, I worked at Consumers Union. At CU, I taught a college class on consumer activism; advocated for state and federal legislation to reduce prescription drug prices; and acted as an internal consultant to improve the organization's advocacy work. In 2008, I was recruited to work for the Communications Workers of America (CWA). As CWA's New York State Legislative and Political Director, I've helped coordinate our advocacy work on a wide variety of issues, including public financing of elections.

After nearly 20 years of lobbying in Albany, I am extremely familiar with the State Legislature. During the session, I travel to Albany roughly every two weeks (and much more during the height of the budget season and at the end of the session). I've worked on stopping telecommunications deregulation, tax and budget issues, health care, raising the minimum wage, and public financing of elections. This past year, my work was instrumental in passage of the Safe Patient Handling Act, which will protect patients and workers from injuries hospitals and nursing homes.

I strongly support public financing of elections and other reforms such as ending housekeeping accounts, rules reform, disclosure of IEs, and closing the LLC loophole. In addition to extensive lobbying on the issue, I have coordinated CWA's grassroots work on the Fair Elections campaign, bringing district-level pressure to bear on several legislative targets and ensuring that every candidate endorsed by CWA supports public financing.

The political culture in Albany is deeply broken – and badly needs extensive structural reforms. As far as I know, I would be the only person elected to the Assembly with extensive experience as a public interest and labor advocate. Most newly-elected Assembly members have a limited understanding of their new jobs. If elected, I would be able to hit the ground running. Over time, I would be able to apply an organizers mentality to the job, and use insider/outside coalition and lobbying campaigns to get results.

For a variety of reasons, there are few people with advocacy and/or progressive labor experience willing to run for Assembly. I am both a policy expert on several issues and an organizing and campaign veteran. I know that if elected I can be part of a new generation that changes Albany's culture – and win real reforms that can open up the process so that deep-

pocketed special interests do not exercise overwhelming control over state government. Thank you for considering my candidacy.
