The 55th Assembly District is comprised the communities of Ocean-Hill, Brownsville, East New York, Crown Heights, East Flatbush, Bed-Stuy and Bushwick. I was raised in the District in Public Housing by my grandmother who is now 91 years old. I attended Public Schools in the District and later Vassar College and Boston College Law School. The District is a high-crime, high-poverty District with unemployment at 3x the city rate and low high school graduation and college attendance rates. Our lack of adequate political representation on all levels has helped to continue these negative trends. The Assembly seat has been held primarily by a member of the Boyland family for the lifetime that I have lived in he community. We have been poorly represented and undeserved for the last 10 years and this election cycle offers us a chance to bring a fresh perspective to politics in the community.

In my district 46% of the residents live below the poverty line and we have the highest density of public housing of any district in the State of New York. Economic inequality is the most critical economic issue of our time. We need a more progressive income tax structure, with higher taxes on high-income New Yorkers. We need to look at other creative ways to increase revenue, like stock transfer taxes, estate tax increases, etc. We also need to increase the minimum wage and index it to inflation, so working families can make enough money to not live in poverty.

Anytime that public dollars are spent we should require tracking and transparency of that spending. The methods that Citizens Union supports for accountability and equalizing of public funds and information access are core values of my ideology and how I hope to govern and be responsive to my constituents.
