1. Toll relief for my constituents. We enacted 1st ever toll plan for commercial vehicles and a resident discount.

2. Betwation of bus service lost in 2010. We successfully forget for and restored X27, X1, 1337, 138, 1364, 1893 has lines.

3. Port Authority Reform. Sued PA in supreme Covet for release of toll impact study. Then tought for legislation to require PA to follow Folk laws of My.

4. Repeal of 18-A assessment. After 4 yes fighting for repeal of this hidden energy surcharge in whity bills, it is scheduled to sunset.

5. Vote against increased debt. Voted against increasing debt limit of MTA and thereties and state agencies.
