I believe that limiting campaign contributions would be an inequitable burden on me as a minority party candidate, because a much larger base of donors supports Democratic candidates here in New York State and City.

I also don't support outright banning of corporate donations as corporations, as legal entities, should also have a voice as active employers and participants in our communities and districts.
