Additional Comments:

I am running as a democrat in the upcoming primary election because I believe in the principals of the Democratic Party. I believe in a fair and balanced government, one that does not create policies that favor one group over the other (often groups of greater means). I believe that women's right to choose, women's pay equality, and marriage equality are not special interests' issues but a human issue, and that both need to be protected and improved immediately. I believe that a council member should work full time, not part time, to serve his/her district, and that earning income outside of government should be strictly limited with full transparency. The 36th district is one that has low primary election participation, so I believe that it's time to test new models—including but not limited to ending primaries as we know them—if that means demonstrable increases in civic participation. I believe in socially responsible economic development, which means working to create family sustainable jobs, and involving the community in the process of economic development so that unmet goods and services needs are at the foundation, and that local entrepreneurship is promoted and actively encouraged, to keep community dollars within the community. I believe in equal, unfettered access to healthcare is one of the key issues of this race, and that policies that have allowed this issue to get where it is need to immediately be thrown out and redone.

- 3. Increase affordable, quality, easily-accessed comprehensive healthcare that also expands access to women's health services and HIV/AIDS prevention and intervention services.
- 4. Work to institute a government that protects the rights of its citizens at its foundation, instead of one that blatantly disregards federally protected civil rights.
- 5. Work to improve the public school system on all levels with an emphasis on vastly improving parental involvement and access.
