TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS

- 1. Preserve and grow our community's affordable housing. I will fight to expand the amount of affordable housing units in our community, revitalize and repair current NYCHA and Mitchell-Lama housing complexes and ensure that people are not priced out of our communities.
- 2. Help the homeless. As a youth I was homeless, that's why I will fight to increase funding and resources for homelessness prevention efforts instead of building new shelters.
- 3. Fix our education system. Too many of our sons and daughters are being failed by New York's schools. That's why I will find and implement real solutions to the overcrowding and poor resources in East New York and Brownsville schools to give every child a fighting chance.
- 4. Improve transportation. For those with disabilities in East Brooklyn, riding the subway is a near impossible transit option. But just like so many other city services, those of us in East Brooklyn are being ignored. That's why I will work with the MTA to install elevators at the subway stops in East New York and Brownsville so those of us with disabilities can use the subways just like all other taxpaying citizens.
- 5. **Prevent crime in our neighborhoods.** When elected, I will bring back community policing to keep our neighborhoods safe while building trust.
