TOP FIVE CAMPAIGN PROMISES FROM LAST ELECTION AND ACTION ON THEM

1. Committed to allocating monies that were promised for security cameras in NYCHA buildings. I secured \$4.5 million to be used to install the security cameras.
2. Promised to create additional Affordable Housing and employment opportunity. In my district, Gateway II is opening in which hundreds of affordable units have been created. In addition, 500-1000 jobs will be created due to new businesses opening up.
3. Promised to support additional funding for Universal Pre-K .The funding has been achieved.
4. Promised to prevent the closure of hospitals in Central Brooklyn and secured funding for their existence. Ultimately secured thousands of dollars for unionized jobs. I am glad to say the hospitals are open and employee's benefits at one hospital have been restored and funding for those that have been secured.
5. Promise to secure funding for infrastructure improvement in Canarsie and areas in the district that was affected by hurricane Sandy. We have been slated to receive between 300-350 million for infrastructure.

TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS

1. To pass legislation regarding the penalties of those who are in possession of illegal firearms.
2. To push for campaign finance and term limits for state legislatures.
3. Secure additional funding to assist residents who were affected by hurricane sandy to rebuild their individual homes.

4. To create a local Regional Council to get input from mom and pop stores to build true local economic development.
5. To create a commission to monitor distribution of funds from DOE to each school. The purpose is to ensure the school funding that has been allocated.
