

He takes work from law firms, regardless of inherent conflicts of interest. He uses his campaign contributions to pay for his luxury SUV, cigars, and to pay off his credit cards. He raises as much money as he wants, from whoever. Worst of all he gets elected year after year with numbers usually seen in third world countries.

Do I want ethics reform? You bet! Bad government costs us not only our faith in government, it costs us in legislators not doing the best job they can for us the people, it also costs us in real money. If a billionaire gets a 421a tax exemption, if there is nobody watching the utility companies, if the brownfield tax credits are abused by developers, we the taxpayer end up making up the difference, or suffering the loss in services.
