9. What is your position on granting the borough presidents the ability to make an additional appointment to the Board of Standards and Appeals?

Additional Comments: It is important to start to rebuild and gain the public's trust. I support all the above, since the office of the Borough President has the authority to address and make changes.

As the Borough President of Brooklyn, I will use the power of the office to support and respect the people who live in Brooklyn. My office will recruit and develop a staff that will canvass the various communities to obtain feedback on what can be done to improve the quality of life in this borough. These concerns will be addressed immediately.

1. How would you use the office of the borough president to impact city policies affecting the borough?

Throughout Brooklyn, we are faced with closing of major hospitals. As the Borough President, I will be a strong advocate in seeing that these hospitals are never closed because of lack of funding.

Brooklyn has the second highest rate of unemployment of all the counties in New York State. As

Borough President I will direct my staff to find solutions to close the gap and help people get

back to work.

Brooklyn has been progressing economically, but despite this growth we still have individuals out of work. We must find ways to continually attract new businesses.

I believe in a good and supportive educational system and as Brooklyn Borough President I will work closely with the Department of Education to see that no child falls thru the cracks. We need to incorporate financial literacy programs for all grade-levels in order to guide student to a better financial future.

2. Developers argue ULURP should be streamlined while community groups and advocates believe more opportunities for input should be provided or that voting thresholds should be changed for application approval. Others note that the ULURP process does not integrate the need to plan for post 9/11 security issues in development. What reforms to ULURP do you support?

Every community has a right to be protected under the ULURP process; therefore, the people living in the community who have addressed such concerns, should be taken seriously and not ignored. As Brooklyn Borough President, I will make sure that the Community Boards and those who have issues concerning the community they live in, are addressed.

There should be plans in place that addresses catastrophes, such as Hurricane Sandy. I will introduce guidelines that key officials will be privy of to help get people or communities back "on their feet" quickly in the event of "acts of God". Also, plans to secure our infrastructure will be kept top of mind.

<u>believe the City of New York should have had emergency plans in place for evacuating the people.</u> Although not every community was hit as hard as others, the matter of evacuation should have been conveyed prior to any disaster. As Borough President, I will see to it that such a plan is in place if we where to face such a disaster in the future. (Although we can never be fully prepared, we can have a strategic plan of action in place that can minimize lost).

3. The borough presidents make recommendations to the mayor on capital projects as part of the budget process. All of the boroughs combined additionally receive 5 percent of the appropriations in the mayor's capital budget divided between the boroughs based on formulas related to land size and population. What would be your priorities for capital projects in the borough?

Several Senior Homes are in need of repair and remodeling, I will allocate funding to make repairs.

Community Centers also require structural repair and remodeling, I will allocate funding to make repairs.

The American Legion Post for war veterans have been neglected for quite sometime and are in need of repair. I will allocate funds for this cause.

I will allocate funds for schools in need of repairs. I will also help fund field trips for students.

Borough presidents are charged with establishing a planning office that, among other functions, provides training and technical assistance to community boards on land use issues. How would you use the office to help community boards fulfill their charter mandated responsibilities in providing feedback on land use proposals while enabling the boards to make decisions independent of the borough president's office?

The Office of the Brooklyn Borough President will provide the needed technical support to assure that all the community boards are well versed on the land use issues, While allowing the Community Boards to work independently of the Borough office and only extending assistance when required.

4. Borough presidents are charged with making hundreds of appointments. What criteria would you use for appointments to positions appointed by the borough president (the Panel on Educational Policy, City Planning Commission, community boards, etc.)? What processes would you put in place for advertising open positions and recruiting qualified candidates that represent the diversity of New York City?

As Borough President, I would use a diversified method. I would open the process to every qualified individual throughout Brooklyn and hire the most qualified person for the job. For example for PEP, I would look for a person who has served on the PTA or the SLT which shows their devotion to the educational system. Also, they must have a child or be a guardian of a child in the educational system, not a grandparent or "use" to have a child in that particular school. For City Planning Commission you must have some form of education other than a H.S. Degree and have working knowledge of the area. For the Community Boards, I would hire independent thinking individuals who can think "out the box" and posses leadership qualities

when it comes to making the right decisions for their community. Also, they should have an attitude to embrace change, especially, when it is bring progress to their community.

5. Borough presidents can hold hearings on any matter of public interest and are charged with establishing a borough-wide complaint program to report public complaints to better service delivery by agencies. How would you use these powers and the position of the office to amplify the concerns of borough residents? What issues might you focus on to improve agency performance or draw public attention to?

Throughout the years, I have been adamant about improving several issues, I do believe that some parts of Brooklyn need to be cleaned up, have safer streets, and adhere to the laws of noise pollution. I intend on addressing these issues with the mayor, police department, sanitation department and leaders/church officials and challenge them to bring about a positive change. I am very concerned when it comes to the safety of people who are afraid to say something because they live in fear of retaliation. I will make sure that the appropriate departments are fulfilling their responsibility of taking care of the matters that need to be addressed first. Nonetheless, these complaints will be addressed in the appropriate time, even if it means creating a special task unit of volunteers that can be recruited to assist in addressing these complaints.

6. The borough presidents have the authority to introduce legislation yet few borough presidents in recent years have exercised this authority. Would you utilize this power, and, if so, what legislation would you introduce?

#### Yes.

Community Board Mangers should be hired through a screening process that qualifies them for the position instead of being handed the job.

- a. As the high cost of living becomes a challenge for some of us, the need for Affordable

  Housing becomes more of a reality to those who are not able to pay the high rent. As the

  Brooklyn Borough President, I will be concern with providing solutions to help in keeping

  families in their home and giving others the opportunity to be able to afford a home to rent.

b. With the recent decision to over turn stop and frisk, Public Safety will be a major concern since criminal offenders will not fear carrying concealed guns. We will have to continue working with churches as well as the District Attorney's office to continue with the buy back program. I will advocate for a restructuring of stop and frisk that will help implement the needed changes so that the communities who have come against it would understand it is vitally needed to prevent crimes and keep our neighborhoods safe.

# c. In terms of Public Transportation, these are the following issues:

More express trains and buses are needed during rush hours. I come to understand there is a major problem with R lines and riders have to wait a substantial amount of time for trains to arrive. This should not be happening during rush hour. (Maybe off peak hours there might be a slight time delay). Also, there are concerns about the keeping the subway cars and platform clean. Overall, I haven't heard of major problems with Public Transportation. Announcements during train and bus rides have brought about some change in the behavior of commuters.

d. Adequate health care is a major concern with individuals today. Also, with the threat of closing hospitals, it would make it difficult for those who need immediate medical assistance to get to a nearby hospital. As I mentioned, I will advocate and fight hard for our local hospital not to close. As for the environment, we need to be mindful to curb our dogs, don't liter and keep our gutters free from debris to prevent our sewers from clogging. Saving plants and greenery as well as, keeping our waterways clean are needed for our ecosystem and environment to

strive. The Brooklyn Borough President office will advocate for clean living throughout the Borough.

e. Economic Development is a must for Borough President Office. I look forward in inviting new companies to Brooklyn to do business and provide new jobs. Also, we need to continue building on the established businesses. In addition, we must move forward and provide assistance to small businesses and support our local businesses. We also need to have additional training for those who are unemployed to help them move back to employment. All these factors taken into consideration should help lower the unemployment rate which has the highest unemployment rate of all the boroughs in New York. I am business savvy, have an extrovert personality and I like seeing businesses do well. I believe these are qualities needed for the Brooklyn Borough President and do bring in businesses. When businesses do well the economy does well.

f. We need to keep our students focused and energized so that they can achieve their goal and aim high for success. Every child has the ability to learn. We need educators and school officials who "cheer on" every child and let them know that they can succeed, regardless of their background. We need school staff that will make a positive difference in students' lives.

Although there are problem within the public school system, we need to address why these situations occur and come up with real solutions. I don't believe any child sets out to fail.

Teachers should be equipped to know about the different styles of learning and incorporate them in their lessons/teaching. I do believe "no child should be left behind". As the Brooklyn Borough President, I will advocate for implementing ways to encourage learning and foster in safe and clean environment which is conducive to learning and helps students be more productive in order to achieve their goals.
