5. How would you use the office of the Public Advocate to impact public policy to serve the broad public interest?

I believe the Public Advocates ability to introduce legislation is the most important power of the office. I will always introduce legislation to shape the direction of our city, especially when the City Council or the Mayor fail to push progressive measures forward.

6. What would be your most important legislative and non-legislative priorities as Public Advocate?

1. I would do everything in my power to hold the Mayor accountable.

2. Three important issues I would focus on are Climate Change, Affordability for tenants, homeowners and small businesses, our infrastructure (MTA, NYCHA) and equal access to

services and programs for all communities.

7. What do you consider to be the three most important oversight functions of the Public Advocate?

1. The Public Advocate being an ex officio member of all city council committees. This is essential to being able to probe and oversee agencies under oath.

2. The citywide platform the office provides, I believe is a power within itself. Being the voice of the public creates a unique opportunity to organize New Yorkers against the Mayor

when initiatives, investments or overall city management isn't working.

3. Having appointments on the Pension Board is also influential in being able to influence how those dollars are invested.

8. The most recent Public Advocate has used litigation extensively, with mixed results, at least with regard to the Public Advocate's standing to bring a lawsuit. What is your view on the Public Advocate's use of litigation to attempt to force policy changes?

I am not a lawyer, but I would hire a strong team of litigators to sue the city on issues it fails to act on. I believe it's an important tool that is used properly can restore justice and

and provide relief for New Yorkers that need it most. As a legislator, I understand first hand that it's not the easy to pass policy changes. The power sue should be an available tool

The city could be more agressive in the fight against climate change. We have to pass legislation that would cool, our city while also improving livability, water and air quality. I believe its time

To ensure all NYC roofs are converted into green spaces. Cities like Portland, Detroit and San Francisco are already mandating delevepments to do so, we should here in NYC.

I will pass legislation creating this mandate on all roofs. New construction and retrofrits. I would also use the bully pulpit to demand more aggressive waste and carbon goals.

10. How would you approach the responsibilities of the Public Advocate regarding access to public information in

monitoring the implementation of the city's Open Data Law?

I would commission a website in the office of the public advocate that would make the cities open data more user friend. It is currently hard for average New Yorkers to navigate and

find the information they need to understand how effective government is working. I would also call for the office of DOITT to provide periodic updates of the data that is being shared or withheld from New Yorkers.

11. What specifically will you do as Public Advocate to ensure New York achieves a full and complete Census count in

2020?

The biggest threat to getting a proper count is the fear of New Yorkers having to include their immigration status. I would create a outreach team dedicate to outreach efforts in

immigrant communities, working with non profits. New Yorkers living in illegally converted units also fail to fill the census for fear that the city would vacate their homes. I would use the bully pulpit to have the Mayor and agencies commit to and ensure New Yorker that the

data will not be used against their housing status.

Public transportation is no doubt a major issue for all New Yorkers. The Public Advocate

has to play a major role in advocating for a seat in the MTA board. I would also travel to albany and advocate for adequate funding and a expeditious plan.

I will work internally with my office to create a dedicated website that would provide New Yorkers with a clear picture of who should be held accountable, how their dollars are being allocated to the MTA, and where the shortfalls lie in repairs. The information empower New Yorkers by bringing them into the process and conversation.

And finally, I would advocate for city control of the MTA to remove all ambiguity on who is responsible for the lack of repairs and service disruptions.

It would also help centralize spending and capital improvements.

Schools need to provide the building blocks for healthy lifestyles and success even outside the classroom. In my district I made sure every public school in my community has a program that delivers fresh fruits and vegetables, and teaches healthy cooking students, parents, and school staff. I'm striving to bring this throughout the city and combine it with my plan to put farms in schools, so students understand the value of the healthy food they eat.

Millions of students also come from tough upbringings and living conditions, almost certainly setting them up to fail in the classroom. I'd like to see meditation and yoga as part of our curriculum, considering they've been proven to reduce stress and stimulate learning in high-need communities. We must try new and innovative ways to give students the tools they need, to lead a more productive lifestyle and improve their chances at being successful. Private schools and public schools in more affluent communities are already practicing this. It not a foreign idea.

Like Letitia James, was able to advocate for Free School Lunches for all, I would do the same with the issues above
