I am honored to have received the Citizens Union endorsement in prior elections; as you know, I am deeply committed to election, ethics, and budget reform, and my actions in Albany prove it. When I was the head of the Elections Committee, I pushed for sweeping reforms in Albany and worked tirelessly to lessen the influence of money in elections. I continue that effort to this day, and will remain faithful to that in the cycles to come.

In the 2012 cycle, I was the prime sponsor of no less than 16 bills that deal directly with election law. Included in these are \$1553B\$, which would amends provisions relating to the information which must be included on applications for absentee ballots for school district elections, \$1556\$, which would enacts the "early voting act", \$1560\$, which provides that tenants of residential real property shall be provided with voter registration forms, and \$1561\$, which would reduce the time for mailing and receipt of registration application to constitutional minimum. I was co-sponsor of 14 addition bills dealing with the issue, including \$1009\$, which prohibits deceptive practices and the suppression of voters, and increases penalties for violations of the elective franchise, and \$1974C\$, which enacts the "voter empowerment act of New York" to streamline the process for registering to vote.

I look forward to meeting with you to discuss these bills, and any others you wish to discuss, and look forward to working with you in the years to come.

II. CAMPAIGN PROMISES MADE TO VOTERS (PAST AND CURRENT)

In addition to evaluating their stances on the issues above, Citizens Union will assess incumbents on how well they kept the promises they made to voters during the previous election.

Five promises from 2010 campaign and what I did for them

Increasing accessibility to state senator: I maintain a 24-hour telephone hotline for my constituents to call at any hour of the day to ensure they remain connected to their elected representative in Albany.

Protecting the Environment – I held my 5th Recycling Collection Day on April 17, 2012, fulfilling my promise to continue to guard and protect the environment. Tons of electronics, paper and books, clothing and textiles, carpeting and household goods were collected. I have also been a vocal advocate of protecting the NYC watershed by opposing fracking in upstate New York.

Job opportunities – I continue to hold job fairs for my constituents, helping in the most hands-on way I know how those seeking employment in our tough economy. The next one is currently scheduled for September, and we anticipate attendance by more than 1000 people. In addition, in April 2012 I held a Veterans (& Spouses) Job Readiness Workshop for veterans returning to the job market, and held a follow-up Veterans (& Spouses) Job Fair on June 8, 2012.

Seniors and budget process – While there was pain in the budget, I stayed true to the principle of shared sacrifice by winning key restorations for school aid, higher education and critical human services like Title 20 senior centers, homeless programs, summer youth employment and juvenile justice reforms

Good govt / ethics reform – I helped pass the comprehensive ethics reform legislation that built on last year's efforts to clean up Albany and give New Yorkers the more open, accountable, and responsible state government they deserve. It was not perfect, but the stronger disclosure requirements, creation of an independent oversight commission, greater transparency for lobbyists, and tougher deterrents for public corruption are a good start to building a state government as good as the people we serve.

Five promises I will make to voters this election cycle

Create jobs and protect small businesses - We are all cheated when we allow companies to reach into our pockets and spend our tax dollars on jobs that aren't available to workers here in New York State. Job outsourcing negatively affects our state and local economies, hurts local residents in need of jobs, and leads to a higher burden on our human services and unemployment systems. That is why I introduced S.1244 that would prevent businesses from reaping state tax breaks and other economic benefits when they outsource employment opportunities to other states and countries. I promise to work to pass that bill.

Funding and accessibility to education -- Early childhood education kick-starts a child's academic journey, and is proven to ensure greater success later on in school. We need to take a hard look at our current day care education programs, and seeing what we're doing right and what we could be doing even better, is an important investment in our future.

Seniors healthcare – I will continue to support title XX funding for our city's seniors, and do everything I can to ensure they have the funding they need to live healthy lives.

Campaign finance reform. We must do more to restore trust in government. We have to take big money out of our elections, ending pay-to-play, and give regular New Yorkers a stronger voice. In addition, I am deeply disappointed that we ended session voting for independent redistricting, and intend to work hard for it when elected to my third term.

Environment – Hydrofracking represents uncharted territory for residents of our state, but one thing is certain: we simply can't take chances with our water quality. I have written to the State Department of Environmental Conservation (DEC) to express my grave concerns about the safety of the process, and I will continue to be out in front of the issue. I will also continue my district-wide recycling days, taking in tons of electronic and other types of recyclable materials that would otherwise end up in our landfills.
