I vehemently oppose the illegal extension of term limits, although they were not struck down by the courts. I have made the term limits issue a cornerstone of my campaign. I have publicly stated on the record that I would not serve more than two terms in office once elected.

7. How would you use the office of the Borough President to have an impact on the city policies affecting the Staten Island?

I would use the office as a "bully pulpit" and not hesitate to go to court to get our fair share of service should I deem it necessary. I have no issue in dealing with the City-wide press and would enjoy using the press to improve our image and services.

8. What would you propose the Department of Education do to increase the ability for parents and teachers to become more meaningfully involved in the education system? What other positives changes can be made to the New York City public school system?

It is imperative that parents learn how to become better involved in their children's education. Stopping before we arrive at the so-called "helicopter parents", most parents need to be dramatically more involved in teaching their children basic values and skills. Teaching to the test is a mistake. Social studies/civics, the arts and phys ed are also important components of educating our children.

9. What characteristics would you search for in an appointment to the Parent Education Panel (PEP)? How would you work with the PEP or support their activities and responsibilities?

I would search for someone with experience and a genuine commitment to the children and their parents, and preferably not someone with purely political aspirations. He or she would also need to have excellent communication and conflict mediation skills, and preferably would also be bi- or multi-lingual.

- 10. How would you leverage the office of Borough President to address:
 - Affordable Housing,
 - Education,
 - Budget and Fiscal Responsibility,
 - Health and the Environment, and
 - Economic Development?

I would encourage the development of affordable housing along the transportation corridors I would be developing. I would work closely with the education experts in my borough and beyond to enhance education opportunities. As Borough President, I will not only spend the discretionary budget more effectively, but I will post online how my fellow taxpayers' money is being spent. I want to have urgent care facilities paid for by HHC placed throughout the borough to lessen the burden on our two remaining hospitals. I wish to establish a Museum of the Environment near the ferry terminal to draw visitors off the ferries and enlighten our own schoolchildren on responsible living. I will demand that the "green roof" be re-incorporated into the plans for the parking garage now under construction in St. George. I will fully develop the retail space in the ferry terminal, and work to preserve the many small businesses currently run by and employing many of Staten Island's residents.

11. What criteria, if any, do/will you have for appointments to the City Planning Commission?

I am dismayed and disgusted that our current appointee is a relative of the BP, lacking a college degree and any city planning experience whatsoever. I would appoint an experienced and educated

professional, preferably someone with a strong environmental background to round out the experience of the other commissioners.

12. What would you propose to ensure that charter-mandated elected offices receive equitable budget allocations?

Equitable budget allocations are necessary to prevent the charter-mandated public offices from becoming mere pawns of the Mayor. After watching the Public Advocate's budget cut by got 40%, I cringe to think what would happen if the BP's budget was similarly summarily cut. With an equitable disbursement, Borough Hall would get it's fair share of the budget to enhance the lives of its residents.

13. What would you propose to further enhance transparency regarding the relationships between elected officials, their families, and nonprofits that receive funding from New York City?

I find it shameful that many members of the incumbent's family are on the NYC payroll in one form or another, most embarrassingly the appointment of his daughter-in-law's sister as a City Planning Commissioner. I am also disgusted that the elected officials get around the nepotism regulations by employing each others' relatives instead of their own. All elected should disclose all family employment with the City. If I had to lobby to make it a law, I would gladly join CU in that effort. In any event, it is clear the serious reform is needed now that officials have figured how to circumvent existing regulations.

It's tempting to say "fire them all and start over". Only our current national financial headaches overshadow the total mismanagement of the MTA. Mass transit is desirable, and infrastructure is sorely lacking, particularly on Staten Island. The only solution is to change this "car culture" currently being promulgated on Staten island in particular.

^{14.} Taking into consideration the lessons learned from the debates surrounding congestion pricing and the Ravitch Commission's recommendations to provide the MTA with long-term funding, what do you think should be done to address the MTA's fiscal solvency issues and ensure that the burden for funding the MTA is equitably distributed among all stakeholders?

15. How will you address the current zoning concerns unique to Staten Island?

The current system allows certain developers who are on the BP's planning advisory board to use insider information to purchase land in areas under consideration for re-zoning and put in foundations prior to the re-zonings taking effect. The ill-gotten profits are in the millions, and are made with the tacit approval of the current leadership. Clearly this must stop. The proposed re-zonings should include a moratorium limiting development while the re-zoning is under consideration.

16. Emergency personnel response times for Staten Island are above average in comparison to the response times in other boroughs. What do you think the city should do to reduce the response times in Staten Island?

For starters, the call command center should be brought back to Staten Island. Much of the Island's street layout idiosyncrasies are foreign to a non-Islander, and having local personnel directing emergency can make the difference between life and death. There are many similar street names, and with the rampant new construction and memorial street names, a non-Islander could easily and understandably become confused.

The number of Staten Island hospitals has shrunk to two as the population has boomed. This is a travesty. This new emergency room was filled to capacity as soon as it opened. This is not enough. We need HHC-funded Urgent Care Centers throughout the Island to begin to bring our health care capacity to acceptable levels.

^{17.} A new emergency room was recently opened on Staten Island at Staten Island University Hospital, which will hopefully address some of the borough's healthcare needs as it is the only borough without a public hospital. What other ways can the city help increase access to medical services to Staten Island residents, and if elected what would you do to help achieve this goal?

Additional Comments:

Serious change is sorely needed on Staten Island. My opponent is the poster child for term limits. There is major frustration Islandwide. The office of Borough President must become more than merely that of a glorified Santa Claus or Robin Hood, redistributing our tax dollars to friends and contributors.
