Oppose

The voters of New York City twice voted in favor of term limits. I strongly believe that the recent overturning of the will of the voters by legislative maneuvering undermines our democracy. Term limits have helped bring a new generation of leaders into city government. New voices and progressive ideas are the tangible benefits from the increased opportunity for citizens to serve. Term limits can help keep elected officials accountable to the public and defend against the abuses of unlimited tenure. The people of New York City benefit when our elections are more competitive and the nearly insurmountable advantage of incumbency is leveled.

I would increase revenue by creating a more progressive income tax code, reinstate the commuter tax, and demand our City's fair share of state and federal funding.

I believe that greater home rule should be granted to the City of New York. The City should be granted more sovereignty over rent regulations, taxes (property, sales, income, and corporate), transportation initiatives, and school governance.

20. Taking into consideration the lessons learned from the debates surrounding congestion pricing and the Ravitch Commission's recommendations to provide the MTA with long-term funding, what would you propose to address the MTA's fiscal solvency issues and ensure that the burden for funding the MTA is equitably distributed among all stakeholders?

Mass transit is critical to our City. We must do everything in our power as elected officials to provide for long-term funding for the MTA. I support congestion pricing in principle. However, I have concerns about the fairness of other proposals that appear to inequitably impact residents of Queens such as bridge tolls. I believe the burden

should be distributed in a fair manner. I support increasing parking fees for both street parking and indoor parking. I am a strong supporter of increasing the gas tax.

21. What would you propose in terms of creating a greater role for the city council in determining and deciding the city budget?

The City Council should have a greater role in determining and deciding the City budget. I believe that having a Speaker of the City Council with greater independence from the Mayor would have a significant impact on the Council's ability to shape and influence the budget. I also fully agree with the Citizens Union recommendations that "chairs and their committees should have greater responsibility in the council's review and approval of the City budget to ensure that the needs of New Yorkers are being addressed equitably and efficiently."

22. What is your position regarding the City's past practice of using surplus tax revenues to pay down future health cost and pension obligations, and the decision not to do so this year?

My position on using surplus tax revenues to pay down future health and pension obligations depends on the economic climate during the given year that such a surplus exists. I think that in the current economic downturn it is critical that we use the surplus monies for immediate needs such as funding social services and creating jobs. However, in periods when the local economy is expanding, I would support using surplus funds to pay down health and pension obligations.

23. What is your view of how the taxes paid by New Yorkers compare to the value that is received in City services? Do you believe that taxes should be raised or lowered? To the extent you believe taxes should be changed, please provide specific proposals about what taxes you would raise and what services you would cut, if you didn't raise taxes, listed in order of greatest magnitude.

The "comparative value" is a difficult question to answer because of the varied needs of individuals receiving City services. I believe that the tax burden on middle class and working class families and individuals is too high. I am a supporter of a more progressive income tax code that would increase revenues by increasing the marginal tax rates on individuals earning more than \$250,000 per year. I would support increasing revenues on the wealthiest New Yorkers before I could support any attempts to reduce essential City services.

24. Many policy advocates champion the creation of a more diversified economy, and one that is less reliant on Wall Street. What is your position on such a plan? If you support it, what would you do to diversify the city's economy? How would you adjust spending in New

York City to accommodate the anticipated reduction in tax revenue as the tax base shifts to lower paying jobs?

I am an advocate for a more diversified economy in New York City. We did become too reliant on Wall Street for tax revenues. I support investing more in higher education to train and prepare our citizens (and future workforce) for higher paying jobs in industries such as alternative energy, biotechnology, and computer technology. I think that areas such as Boston and the San Francisco Bay Area have benefitted tremendously from their emphasis on higher education and their ability to retain students in their workforce in high-paying jobs in the local economy.

25. What would you propose the Department of Education do to increase the ability for parents and teachers to become more meaningfully involved in the education system? What other positives changes can be made to the New York City public school system?

As a NYC public school teacher for twenty-five years, reforming the Department of Education is a top priority. We must have parents and teachers playing a more meaningful role. I propose strengthening school leadership teams to give parents and teachers a greater voice in the process. I would also advocate that an evaluation system for principals and the chancellor be created for parents to have an easy, simple, and direct way to express their concerns regarding the effectiveness of school leadership.

26. What would you propose to increase the transparency of the Board of Elections in the City of New York's operations and accountability to the city and its voters?

I propose that the Board of Elections should eliminate patronage positions and create a more professional staff by making these civil service jobs. I also will advocate for more reliable and modern voting equipment. I also propose that the BOE create a more user-friendly website.

27. What would you propose to further enhance transparency regarding the relationships between council members, their families, and nonprofits that receive funding from New York City?

I will sponsor legislation that prohibits City Council Members from funding non-profits that employ family members in executive or policy-making positions. I will also advocate for greater transparency regarding the employment of family members.
