Knowing that the police department and commissioner retain ultimate authority for determining whether an officer is guiltily and penalty, what is your position on transferring power to the Civilian Complaint Review Board to prosecute cases of police misconduct, such as force, abuse of authority, discourtesy, and offensive language? a. In FY 2008-09, New York City spent \$12 billion on pensions and fringe benefits for City employees out of a total budget of \$62 billion. What would you do to address the growing pension costs borne by the city and New York City tax payers?

I would work with the Comptroller's office to make sure we understood how these monies were being used. If there was misuse or waste of any kind I would work actively to hold those agencies responsible and also ensure that could not happen in the future so that we can ensure proper use of our budget and also ensure that our City employees are well cared for and properly compensated for their hard work fairly and effectively.

- 19. What is your position with respect to the City Council <u>Support</u> Oppose passing a resolution calling upon the State Legislature to establish a State Constitutional Convention?
  - a. If support, what are the three most important areas that need improvement?

There is too much self interest in our local government. We need to increase involvement of our citizens and community in the democratic and electoral process, and we need to ensure that real diversity exists to make our government truly representative.

- b. Do you believe that greater home rule should be granted to the City of New York? If so, in what areas should further sovereignty be given?I think perhaps one of the most urgent is URSTADT.
- 20. Taking into consideration the lessons learned from the debates surrounding congestion pricing and the Ravitch Commission's recommendations to provide the MTA with long-term funding, what would you propose to address the MTA's fiscal solvency issues and ensure that the burden for funding the MTA is equitably distributed among all stakeholders?

What we aren't talking about enough is the use or misuse and waste of funds in the MTA. While congestion pricing may generate significant income, there was no promise that it would go into the MTA and once there, there is no guarantee it would be used properly. We must have better oversight and accountability or we will keep finding ourselves in the same problem over and over again. We should not have to pay fare hikes because our agencies our misusing our money.

21. What would you propose in terms of creating a greater role for the city council in determining and deciding the city budget?

There currently seems to be an unnecessary 'mystification' of the budget process at City Hall, both for the public and the elected officials. Let's set the City Council up for success, utilizing technology, accessibility and transparency so that we all easily and readily know what is going on.

22. What is your position regarding the City's past practice of using surplus tax revenues to pay down future health cost and pension obligations, and the decision not to do so this year?

I think the working men and women in this City depend on their pensions and their health insurance and they should have a right to them. It is literally an issue of life and death for many. This is not how we solve the financial hardship of New York City, by taking away pensions or health insurance of our workers.

23. What is your view of how the taxes paid by New Yorkers compare to the value that is received in City services? Do you believe that taxes should be raised or lowered? To the

extent you believe taxes should be changed, please provide specific proposals about what taxes you would raise and what services you would cut, if you didn't raise taxes, listed in order of greatest magnitude.

My opponent in her State of the City Address echoed the call of many for a progressive tax scheme that would raise billions of dollars to solve our financial difficulties. This scheme would only impact a small number of New Yorkers with a very small increase of less than a percent, who made \$300,000.00 per year or more. She also assured us that she would not support an increase in sales tax, stating it would unfairly burden small businesses and all New Yorkers. I agreed. Unfortunately, when Mayor Bloomberg rejected these ideas, saying it would be unfair to the "rich" my opponent changed her position. My opponent flipped her position, refusing to offer us a progressive tax scheme that would raise billions and help solve our financial crisis, and instead in concert with Mayor Bloomberg did exactly what she called against and increased sales tax, thereby creating more of a problem for our City financially but giving a break to the wealthiest New Yorkers. I would stand up to Mayor Bloomberg and to the wealthiest. I would honor my commitment to fight for progressive tax schemes and in doing so solve our financial crisis.

24. Many policy advocates champion the creation of a more diversified economy, and one that is less reliant on Wall Street. What is your position on such a plan? If you support it, what would you do to diversify the city's economy? How would you adjust spending in New York City to accommodate the anticipated reduction in tax revenue as the tax base shifts to lower paying jobs?

First, as I stated earlier, I do have a plan that would avoid this tax shift. Moreover, I believe that the way we got ourselves out of the economic problems created over the past decade, is with new leadership that creates living wage and union wage jobs. We need to create work and jobs by supporting our unions and supporting small businesses. This ensures we have more people working at living wage jobs that will add to those contributing to the tax revenues.

25. What would you propose the Department of Education do to increase the ability for parents and teachers to become more meaningfully involved in the education system? What other positives changes can be made to the New York City public school system?

Here is a statement released from me last week on the current crisis in education:

## YETTA KURLAND SUPPORTS EFFORTS TO HELP PARENTS HELP SCHOOLS, RENEWS CALL FOR EMERGENCY EDUCATION TASK FORCE

"Let's learn from Bloomberg's mistakes. We have an incredible chance right now to learn from past mistakes and create an effective model for our City's schools that includes community and parental involvement as a central force for solving past problems. We want our Mayor to stay responsible and accountable but we need educators to solve the problems of education and we need feedback from our community and our parents to guide our vision. Let's set up an Emergency Education Task Force to come up with new ideas to solve these old problems;

**Poor planning** -- "There are not enough kindergarten seats for children entering the public school system. The Community Education Council of School District 2 estimates that hundreds of children are on waiting lists for kindergarten.

**Poor administration** -- "In 2009 the high school drop out rate is way too high. Only 53% of New York City children graduate from high school within four years -- only a 1% increase in graduation rates since mayoral control went into effect seven years ago.

**Poor curriculum** -- "In 2009 our children do not receive a well rounded education. Science, history, geography, the arts, music, and drama are neglected. In New York City, a beacon for the arts and sciences, our children should be given comprehensive educational opportunities.

**Poor facilities --** "Our New Yoek City children need education facilities that will make them productive in our 21<sup>st</sup> century community. Our children need up-to-date science labs, libraries, technology facilities, art and music studios, and gymnasiums.

"Overcrowded schools, high drop out rates, neglect of music and art, out-dated facilities – we need an "EMERGENCY EDUCATION TASK FORCE" now – in 2009 – to deal with this year's problems. Mr. Mayor, City Council, are you listening to the people?"

26. What would you propose to increase the transparency of the Board of Elections in the City of New York's operations and accountability to the city and its voters?

I would work with my community and good government groups like Citizens Action to come up with a system that was non-partisan, that gave everyone an equal opportunity and in so doing was committed to raising the standards and creating the best candidates, and therefore the best elected officials.

27. What would you propose to further enhance transparency regarding the relationships between council members, their families, and nonprofits that receive funding from New York City?

As I said in earlier questions, we must increase knowledge, access and transparency and ensure that all our held accountable for their actions.

#### 28. Additional Comments:

This will be an historic election that will measure our ability as citizens of this City to realign democracy when it has been compromised by our elected officials. This election will also determine to a large degree whose interests this government represents and whether it will continue to be motivated by self interest or can truly rise to its calling for public service. The term limits issue typifies this but there are many other important issues at play that are impacted, development, education, affordable housing, etc.

I am running to restore our voice to local government and integrity in our democratic process. I have worked closely with Citizens Union last Fall in our shared efforts to stop the extension of term limits without a referendum. We did not win that victory through the legislature or in the judiciary. We now have an opportunity on September 15<sup>th</sup> to win that fight when we head to the polls to let our elected officials know that they work for us and that no elected official is indispensable, rather it is the process of democracy that is indispensable.

I would love the continued support of the Citizens Union in this effort, and it would be an honor to receive your endorsement and have the opportunity to work with you towards this shared goal.
