Election Reform

I stand fully in support of efforts to make our election process more accountable, transparent and secure. To ensure that we remove barriers to citizens who wish to cast their ballot, thus ensuring that every vote counts; I support policies such as "No Excuse Absentee Voting", allowing same-day registration and weekend voting along with other necessary election reform policies. I plan to work with the Legislature to take steps to implement voter-friendly election reforms to ensure that all citizens are provided an opportunity to cast their vote. I also sponsored legislation A4349 to allow New Yorkers on parole the ability to vote.

Campaign Finance Reform

Over the past decade the cost of running for office has dramatically increased. Money has unfortunately become a major factor in elections; thus leading candidates to rely heavily on donors and special interest groups seeking influence to help get them elected.

When I was elected in 2008, I pledged to always put the people of my community before politics or special interest. For these reasons, I fully support the enactment of a matching public system for statewide and legislative races. I believe that by regulating contributions, tightening enforcement and requiring greater disclosure and reporting of campaign contributions and expenditures as well as independent expenditures, we will be able to reduce the influence of money in the election process.

Ethics Reform

Ethics reform is needed now more than ever. We need to restore the people's trust in government. This year, I supported the "Public Integrity Reform Act" which establishes penalties and regulations to improve ethics enforcement. Although we have made much progress, there is still much more to do. It is imperative that we create a stronger ethics enforcement commission, which would have jurisdiction over lobbying violations, legislative ethics violations, and campaign finance enforcement. This change would allow the commission to fully monitor all intersections of money in politics. I will continue to support any legislation that helps us accomplish these goals.

Budget Reform

In the Legislature, we need to pass reform that restores integrity, increases transparency, and fosters efficiency in the budget process. The process should allow for substantive public debate on budget decisions, especially during these fiscally challenging times. As I seek re-election, I am committed to working with my colleagues in the Assembly to ensure that we work towards meaningful budget reform. In 2010, I sponsored legislation A10116 that requires member items to be equally distributed among all legislators.

II. CAMPAIGN PROMISES MADE TO VOTERS (PAST AND CURRENT)

In addition to evaluating their stances on the issues above, Citizens Union will assess incumbents on how well they kept the promises they made to voters during the previous election.

TOP FIVE CAMPAIGN PROMISES FROM 2010 AND ACTION ON THEM

- 1. Economy and job creation: This year, I supported legislation to provide a tax relief on clothing and the creation of new jobs. The 2012-13 State budget provided funding for the Empire State Economic Development Fund (\$50.4 million), the Jobs Now Program (\$16.2 million), the Urban and Community Development Program (\$7.4 million) and the Military-base retention efforts (\$5 million). I also supported and voted in favor of the minimum wage increase in the State.
- 2. Quality affordable housing: I recently introduced legislation A10170 to require the State Division of Housing and Community Renewal to verify that there are no more than A, no B, and C housing code violations on the property prior to authorizing a rent increase based on major capital improvement in rent controlled and rent stabilized apartments. The 2012-13 budget increases funding for essential preservation programs by \$2.2 million. A total of \$14.3 million will be dedicated to the construction and rehabilitation of quality, affordable housing. More than \$10 million is earmarked for the Neighborhood Preservation Program and \$4.2 million for the Rural Preservation Program. Last year, the programs were funded at \$8.48 million and \$3.54 million, respectively.
- 3. Public Safety: public safety and crime reduction are one of the most important issues affecting New Yorkers. For this reason, I introduced legislation A8198 "Safe Street Security Camera Registry Act" to create a registry of cameras located in public spaces for the purpose of public safety enforcement. I also voted in favor of legislation A10712 to prohibit bullying and cyberbullying in public schools.
- 4. Education: This year, I supported the passage of the 2012-13 State Budget which increased school aid by \$805 million statewide and \$292 millions for New York City schools. It also increased community college base aid for the first time in five years (A.9057-D).
- 5. Senior Citizens: I also voted to pass a restoration of co-payment assistance for the EPIC enrollees in the 2012-13 state budget (A.9056-D). New Yorkers, including seniors in my district, continue to struggle in these tough economic times. It was important to restore EPIC funding in the 2012-13 state budget to make sure that many seniors can pay for their medications and that they receive assistance during the hard times they are facing.

- 1. Help create programs and support legislation that provide more affordable housing for New Yorkers
- 2. Support legislation that enforce ethical behavior and increase accountability and transparency
- 3. Support more educational and after school programs and increase funding
- 4. Continue to support and propose legislation for public safety improvement
- **5.** Ensure New Yorkers have access to the best health care possible by supporting and/or proposing legislation to improve our health care system
