#### Additional Comments:

I thoroughly support Citizens Union reform agenda with respect to elections, accountability, budgeting and reform. I believe on a very foundational level, that the starting point needs to be a shift in perspective of what public office is about: it is about being a servant of the public first and foremost, not to serve the interests of the elected official. It is about sacrifice of that individual for the needs of the community he/she seeks to represent. Initiatives that serve to direct public servants toward this perspective are working toward the greater good.

As a longtime resident of New York City, and a member of a minority party, I also am in a unique position to identify how inequitable the system really has become, and how that inequity builds upon itself. The fact that 47 of 51 seats in the City Council are held by one party is not healthy for the City of New York, and I would say the same thing regardless of what party held 92% of the seats. This is a recipe for groupthink, patronage, stifled debate, and ultimately bad policy. It also serves to show how stacked the system is for incumbents and the dominant incumbent party. Monopoly in any context breeds corruption, apathy, laziness and suppresses the emergence of bold, new ideas.

Although I support the Citizens Union policy proposal of eliminating primaries and making elections non-partisan, in practice I think this will be hard to implement. Though not necessarily a good practice, people find party categories useful because the label removes the onus on them to evaluate the candidate's policies. Even if the party label were removed, I believe an informal "party labeling" would still occur and people would vote based on these informal labels instead. This would eliminate

party vetting, but still produce candidates loosely lumped together based on the interest group labeling them. I think that the funding of candidates would still occur based on these party labels, even if New York abolished party labels on the ballot. That said, I still support the idea as I believe it moves us in the right direction, and it forces voters to become more familiar with a candidate's policies rather than making policy assumptions solely based on party labels (which are becoming less and less effective as policy stance indicators over time).

With respect to public safety and police initiatives, I support ensuring that any misconduct is routed out, but I would stand against any policy proposals that inhibit the police from conducting their work efficiently. As Citizens Union recognizes, New York has become one of the safest cities in America, and this is due to good policy and hard work by New York's finest. Preventing the police from effectively performing their jobs is not good for maintaining this trend, or for the morale of the police force who put their lives at risk to keep our city safe.

As a CPA, an MBA, and having worked in government reform in many contexts, I am well aware of how budgets are manipulated to feed the interests of those holding the most seniority and power. Leveraging the internet to break down the walls that protect these inequitable interests, and maximizing transparency should also be integral to the culture of all public servants. Anytime a public servant makes a budget decision, the litmus test should be whether that decision would pass public scrutiny. It is, after all, the public's money. The more policy and budget information is made publicly available, the more informed the public, and the less the risk of abuse of power.
