## **Additional Comments:**

I fully support almost all of the Citizen Union's initiatives, and whether as a Council Member or a private citizen, would like to see them go further. For example, in campaign finance reform, Public financing is a great step and important in NYC, but large donations can still dominate city wide elections. As important, the Council (and state legislature) must be a full-time job – albeit with significantly increased pay. We can't responsibly serve two masters – the public and also private clients. It's a system set up to be abused.

Additionally, your Council and budget reform initiatives are absolutely critical. The member item situation is out of control – and needs to be reformed - but so too must the almost unlimited power of the Speaker. A 1 and 51 system diminishes the City Council, and democracy and must be changed at both the Council level, as well as in the City Charter. The Council needs to regains its rightful position as the City's legislative body, which means greater power and independence for individual members to introduce and pass legislation. It also means playing a much greater role in determining the City's budget, for which your transparency initiatives are absolutely critical. It is folly to expect the Council to play an active role in determining the budget, when it doesn't have detailed information – including projections. And the committees should have larger budgets to do this work independent of the Speaker and certainly of the Mayor.

Lastly, given the importance of Education in this City, the role it plays in our economy, the millions who are part of the system, and the amount of funding it consumes, I would love to see the CU focus it's transparency and reform initiatives there. This would include bringing the Education budget back under the Council's purview. Currently, even the Speaker admits that she doesn't know what's in it – even though it represents one of every three dollars we spend! And I would contend that the DOE – ruled by the current system of Mayoral Control in which one person (and his PEP) determines every aspect of policy, contracts, personnel for 2.5 million parents, teachers, students, and administrators – is quite possibly the most anti-democratic and least transparent agency and institution in the Country. The CIA and NSA are more accountable than the DOE. There is no aspect of the system that the Mayor doesn't control – except perhaps tenure for teachers - and there is no recourse for the stakeholders other than waiting 4 years for a new election.

All that said, I believe we as New Yorkers and citizens are incredibly fortunate to have the Citizen's Union around and doing its great and absolutely critical work. I would hugely honored to receive your "preferred candidate's" status.

## **TOP FIVE 2013 CAMPAIGN PROMISES**

- Vote and pursue issues especially in regard to land use and development in our district and the City – in which the interests of the district's constituents - rather than party structure and loyalty, other elected officials interest, or moneyed interests – are paramount. Requires increased planning for and by larger community, not just the development community.
- 2. Lead the Council and City toward "real" education reform which focuses less on competition and more on local control and collaboration among the main stakeholders – parents, students, teachers – and tending to our interests. These include focusing on the 96% of kids in public schools, not just the 4% in charters; recognizing and addressing the massive impact of poverty on our schools; providing smaller class sizes; wrap around services and early childhood learning; ending high stakes testing; replacing the network system with locally-based superintendents; and establishing a broad-based (not test-based) accountability system which includes our leaders at Tweed, and not just teachers.

- 3. Get involved in the budget and provide more accountability for spending at the City level, including evaluating more closely how the entire \$74 billion is being spent. Holding ourselves and the mayor accountable to spend and invest wisely and for real investments in our community rather than simply looking at short term imperatives or listening to those with the strongest lobbyists. Eg. Investing in child care, job training, and proven education initiatives where a dollar spent today is returned 3 and 4x. Also seriously pushing toward revenue increases via higher taxes for the wealthy both locally and at the state level.
- 4. Actively pursue and pass initiatives including increased affordable housing, living wage legislation, and as above budgetary focus on our most vulnerable which diminish the massive and growing wealth gap in this City and ensure maintained affordability for the working class and seniors in this city.
- 5. Pursue and pass concrete environmental improvement initiatives leading to increased recycling rates, and lower carbon output.
