## Francisco's Story

Francisco Moya is a lifelong resident of Corona, Queens. At the age of 15, Francisco started the Corona Gardens Neighborhood Association with a group of concerned neighbors, which focused on civic activity in the community. Those activities ranged from starting a block watch program to setting up beautification drives that helped plant trees in the community, as well as working with the 110 Pct. Council to remove graffiti from the neighborhood.

After graduating from St. John's University, Francisco went to work in Washington D.C. for two members of Congress; Congresswoman Nydia Velazquez and Congressman Brad Sherman. Francisco gained experience from working in Congress and came back to the neighborhood to put that experience to work for us.

Francisco was selected to the National Urban Fellows Program to get his masters in Public Administration. Out of 3,000 applicants from across the country, only 29 were selected. Francisco became the youngest person selected to the program and the first to ever be selected from Queens, NY.

After graduating from the National Urban Fellows Program, Francisco was hired as the Special Assistant to the Senior Vice President for the Queens Health Network at Elmhurst Hospital. Francisco was instrumental in securing \$250,000 from a federal grant with the help of Congressman Joe Crowley for a new mammogram machine. Francisco was promoted to Associate Director of Business Development at Elmhurst Hospital were he helped in the expansion of the Hospital.

In 2003, Francisco became the Secretary to the Senate for Senate Democratic Leader David A. Paterson. Francisco was then the highest-ranking Latino in State Government. Francisco was instrumental in helping craft significant legislation in the state Senate that helped all New Yorkers. Francisco was also one of the architects that helped the Senate democrats bring sweeping victories to the party during the 2004 and 2006 elections.

Francisco is currently working for one of the largest multi-media companies in the country were he handles all the Government Relations work for the company.

Francisco was appointed as Democrat District Leader at Large by the Democratic Organization of Queens in 2000. He is a member of the Corona Lions Club and a volunteer at the St. Leo's Golden Age Club. He is the founder of the Corona Gardens Neighborhood Association and helped start the after school sports program at St. Leo's school. Francisco chairs Congressman Crowley's Latino Advisory Committee, and has been honored by numerous public officials for his tireless work on behalf of his community.

Comments: <u>I believe the Ravitch Commission report is, in general, a serious and balanced way to approach preserving a vital NYC institution and resource.</u> Public transit truly makes this city run, and we must take serious steps to preserve it. The 7 train is a lifeline in the 21<sup>st</sup> District, and, as Councilmember, I would be a strong advocate for mass transit. However, I believe that the proposal to add tolls to the East River and Harlem bridges is unfair to the residents of the outer boroughs. Too much of the burden of funding is placed on the residents of the 21<sup>st</sup> District and other working families outside of Manhattan. I do think congestion pricing on those bridges and tunnels that already have tolls is an excellent way to go. Finally, I think we need to explore additional options to generate revenue, including the possibility of bringing back the commuter tax and selling under-utilized MTA properties.

## Top 5 promises you are making to the voters during this campaign:

- 1. City government needs to play a role in fixing our economy at a local level. The right policies drive job growth. We need to provide incentives to companies that make a commitment to our neighborhood and provide stable jobs. I am committed to working with the business community to develop create new jobs and to make sure that government policy promotes the creation of new jobs and the retention of jobs for our community. Decent jobs and living wages are the key to success for our families and our community. I am also committed to making sure that government plays its role in helping all New Yorkers through these tough economic times.
- 2. Even as housing values are falling elsewhere, too many people in our community struggle to afford a place to live. With real leadership in the City Council we can fix this problem and make sure that hardworking people never lack for housing. I am committed to using the power of my office to create new units of affordable housing right here in our community. I will work with developers to make sure that new construction in our community result in new units of housing that are truly affordable for the families of this district.
- 3. Every family has a right to quality, affordable, and accessible healthcare. We need to provide coverage for the uninsured, and I will make sure that the City Council plays its part in conjunction with the Federal and State government to do just that. In approaching the reform of our healthcare system, the needs of patients must be put first, not the needs of insurance companies. We must also make sure that prescription drugs are available at affordable prices. For our seniors and for all of us, no one should have to choose between prescription drugs and food for their family.
- 4. Making sure our children receive a world-class education isn't a matter of choice, it is a necessity. By supporting our teachers and fully funding our schools we will strengthen our community both now and for the future. I am committed to policies that result in lower class sizes, and make sure that our children and our schools have the resources they need. I will fight to make sure that the money that our schools are entitled to from the Campaign for Fiscal Equity ends up in our neighborhood classrooms. I also recognize that extra-curricular activities, such as music, art education, and athletic programs are a critical part of every child's development. Our children deserve nothing less.
