What is your position on allowing independents to vote in party primaries?

I do not support allowing independents to vote in primary elections. I believe this greatly diminishes the importance and integrity of party primaries insofar as that it could be used as a tool for either party to skew the electoral process. Independents could be used to flood a primary to elect an undesirable candidate in order to give another party an unfair advantage.

I support any and all public referendum to encourage voter participation in the creation of laws and city charter revisions.

If fiscally possible I would support an increase to poll workers above the current \$200 they are allotted per election event. Poll workers perform an extremely important part in the election process. Not only do they ensure that voters are afforded the opportunity to vote quickly and properly, they also protect the process from being corrupted or abused. Consequently, they should be compensated fairly for their service.

TOP FIVE CAMPAIGN PROMISES BEING MADE IN 2009

- 1. The city council should be a full time job not a part time job as so many members treat it. I pledge that when I am the council member for district 32 I will treat it as a full time job and my only job.
- 2. Seniors of district 32 must be protected .I pledge to do all I can to keep senior centers open and fully operational. We must insure our seniors receive the services and meals they require. I also pledge to oppose any property tax increase to seniors.
- 3. I do not believe we have explored every alternative before considering toll increases. Residents should not be charged to travel in their own community. I will fight to prevent any toll increase, especially when our citizens do not have the infrastructure to choose an effective means of travel.
- 4. I do not believe we can solve our current fiscal problems by taxing homeowners or businesses. This increase burden will drive our tax paying residents and businesses to other areas outside New York City. I will fight to cut government waste and ineffectiveness before increasing the tax burden.
- 5. The 32nd Council district is grossly underserved by public transportation. I pledge to fight for more express buses and better mass transit service, including the need to eliminate the need for transfers for services to our rockaway community. We also need newer trains. I will fight any attempt to cut express bus services in the 32 council district.
