COMMENTS FOR CITIZENS UNION QUESTIONNAIRE

- 1) I would support the elimination only under these conditions: if elections require that all candidates must participate in the campaign finance program or limit candidates' spending.
- 3) Creating transparency is essential as we determine the most effective ways to ensure accuracy on balloting.
- 5) I would need clarity about how the information would be transmitted. I do favor scanning of documents in part because it creates transparency.
- 8) I support all efforts in educating people on the voting process and providing them with as much information as possible to make educated, informed and democratic decisions in elections. Especially appreciate the efforts to receive them electronically because it is environmentallyfriendly.
- 11) We must be vigilant in our oversight of the campaign finance law, but not all lobbyists are abusing their relationships and or taking advantage of the campaign finance laws
- 13b) I support in principal, but we need checks and balances and that often means making sure there are other voices participating in these decisions.
- 15) This takes away the freedom to vote in a fair and balanced way. If not the council members decisions are tied to the Speakers' preference.
- 20) If they are purely political...how will that benefit the people?
- 21) One question that must be taken into consideration is how will the newly created position of Inspector General work with the CCRB?
- 28) The community boards were established to receive input from the community. They should not be comprised of people who are making policy because of political interest. The public should know more about who is representing them. If elected I would establish a community process for making appointments. We need to make sure people are aware of the important role a community board plays in the community. I will bring this to light as a city council member.
