### TOP FIVE CAMPAIGN PROMISES FROM LAST ELECTION AND ACTION ON THEM

1. To maintain a full time District Office to serve constituents. My District Office is open 5 days a weeks and it has been serving almost 4000 person each year.
2. To support equitable funding for our schools. I have continuously spoken for and held rallies and campaigns with parents fighting for equitable school funding.
3. I actively participated in winning funding for universal park funding for NYC.
4. To increase funding for Higher Education funding to increase the college opportunity for all qualified students. I served as member of Higher Ed. Budget Committee.
5. Fighting to support increase in TAP, and in monies to CUNY and SUNY Community Colleges.
6. To fight against the Southwest Bklyn Garbage Transfer Station. I led rallies and petition drives against the building of the garbage station. I started a lawsuit against the permit ~~and~~ as a pro bono attorney and petitioner. This lawsuit is continuing on appeal to the Appellate Division.
