I have testified at virtually every opportunity before State legislative and City Council hearings on election reform and the conducting of our elections. As such I have testified in support of Items 7 and 8 in the past, as well as supported and advocated for the Board of Elections' implementation of legislation signed by Gov. Patterson, permitting 17 year olds to work as pollworkers and to permit poll workers to work one of two shifts. The Current 18 hour day is simply too long, and leads to excessive pollworker fatigue and decreasing concentration — especially needed at closing, when they are hungry and exhausted, which inevitably leads to lowered quality of performance and reduced voter confidence.

- 3. I do not believe that the current number of signatures required to be on the ballot for Assembly (500), is burdensome and witness signature requirements have become less stringent. I have serious concerns regarding County Committee Members. The process to qualify individual members, by Election District, seems pointless; it is so burdensome, that some AD's don't even bother to fill such positions through petitioning. I would support lowering the number of signatures (12,000) currently required to appear on the ballot for Supreme Court through direct petitioning, outside the county judicial convention system. See *Lopez-Torres v. Board of Elections*.
- 6. I will not support Election Day voter registration until the Board of Elections enters the 21st Century and can verify that a person has not registered at another location. There are too many names listed on the current roles of voters who no longer reside in the district, whether the voter has moved or is deceased.
- 10. I support the idea wholeheartedly. I have grave doubts as to the feasibility. See No. 6 above.

- 24. I have mixed feeling about this item. Conceptually, I support it, but as a professor who taught the judicial externship seminar at Fordham Law School for many years, I have studied this issue. History shows us that no system is immune to political influence, power brokering or money.

TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS

- 1. Health Care: The closing of Long Island College Hospital (LICH) has shown us that our health care system has become more concerned with profit than patients. One of the most disturbing aspects of the LICH issue was that it brought to light the appalling lack of reliable data on local health care needs. If I am elected to the State Assembly one of the first bills I will introduce will be a Health Care Management Information Act, to ensure that decisions about the future of health care facilities is based on fact, not political conjecture. Under this legislation information would be collected for such things as wait times in ER's throughout each county, the length of time from admission in ER to reaching a bed on the floor in the hospital, the length of time from calling 911 to reaching an ER, deaths due to asthma, any other pulmonary disease, cardiac disease presented by neighborhood, numbers of births at each hospital, wait times for pregnant women needing beds/stretchers pre and post partum at each hospital, and the percentage of women admitted in labor with no pre partum care. The State Department of Health would be required to report this data annually to the legislature.
- 2. **Education:** our first obligation is to our children and fulfilling the promise of the court's decision in the Campaign for Fiscal Equity decision. I would achieve this by working with the network of parents I've and educators I been working with to expand awareness, address issues of class size (a top priority of parents for many years), and equal access to precious resources in other areas inside and outside NYC who are also being shortchanged by NYS.
- 3. **Transportation:** As an experienced and effective advocate for progressive and environmentally just and sustainable transportation policies and as an advocate for those with disabilities I will continue to fight for a transportation system that serves all of our citizens.
- 4. **Election Reform:** I will continue to work for key reforms like public campaign financing, overhauling the administration of elections, and voter reforms like early voting and no-excuse absentee voting. I will work with other progressive legislators to build a coalition in support of these long overdue reforms.
- 5. No Albany fundraiser- to help reduce the "pay-to-play" culture that persists in Albany, I will not hold a fundraiser in Albany.
