- #9 Party affiliation is informative. A few years ago, in response to a Charter amendment proposal to implement non-partisan elections in New York City, I joined a letter in opposition to this proposal which stated in part: that non-partisan elections undermine democratic politics and the ability of our citizenry to participate fully and knowledgeably in the electoral process; put less-informed voters who tend to be lower-income, minority, and immigrants at a disadvantage; depress voter turnout; and favor incumbents or other candidates with name recognition.

- #13 I was the original sponsor of the Assembly matching fund bill in 1979, which became the model for the NYC law.
- #16. It would be important to make sure that such PACs clearly identified the corporation with which each is affiliated. Also essential to apply a single contribution limit to all of an entity's affiliates, subsidiaries, etc.

# **II. CAMPAIGN PROMISES MADE TO VOTERS (PAST AND CURRENT)**

#### TOP FIVE CAMPAIGN PROMISES FROM LAST ELECTION AND ACTION ON THEM

I tell people what I stand for, what I have done, and what I plan to work for. Here are some of the major things I talked about in 2012 and what I have done since then:

1. <u>Health care</u>. As chair of the Assembly Health Committee, I consider moving to universal health care the most important public policy issue facing New York. I support publicly-sponsored publicly-funded health coverage for everyone, though my single-payer bill, "New York Health." This year we have developed dramatically increased support, especially in the labor movement.

For many years I have been sponsoring and working to enact medical marijuana legislation in New York. We have finally achieved that goal, with legislation just signed into law by the Governor.

I helped protect eligibility and benefits under Medicaid. I led the successful fight to have New York State enact a law this year to take advantage of the Basic Health Program option under the Affordable Care Act. This will enable hundreds of thousands of New Yorkers to receive free or more heavily subsidized health coverage.

As the state moves virtually all Medicaid coverage into various forms of managed care, I have been working to protect the rights of patients and health care providers.

I worked on implementing federal health care reform and take advantage of new provisions to promote "medical homes," accountable care organizations, and a health benefit exchange.

I also worked to protect funding for "safety net" health care providers, especially community health centers and school-based health centers.

I continue to be the leader in the Assembly in protecting reproductive choice.

- 2. <u>LGBT rights</u>. I continue to be the lead sponsor of GENDA (transgender civil rights), which has over 70 Assembly co-sponsors and passed the Assembly again. As Health chair, I have fought to protect funding for the LGBT health and human services network.
- 3. <u>Promoting economic fairness and opportunity</u>. I sponsor and co-sponsor a broad range of bills to strengthen tenant rights and the rent laws. I devote a large portion of the work of my district staff to helping tenants with rent and housing problems and protect and increase the supply of affordable housing in my district. This includes protecting affordable housing from being replaced with high-priced housing, and fighting to increase the portion of new housing that is affordable.

I supported universal pre-K and middle school after-school programs, including funding through a high-income surcharge.

I supported a higher minimum wage and the right of New York City and other municipalities to set a higher minimum wage.

4. Protect and improve neighborhoods. I have continued to work with tenants, community groups, community boards, and others against excessive development and to include as much affordable housing as possible in new development. I help get buildings landmarked and areas designated as historic districts. I also work to protect tenants whose landlords are trying to force them out to replace them with higher-paying tenants.

The 1998 legislation that created the Hudson River Park, which I authored, was the result of decades of work by me and many others. I have constantly worked to protect the Park and get funding for it. The Park now faces extraordinary capital maintenance costs. I worked with the Hudson River Park Trust, the community, and park advocates to enact legislation in 2013 to provide additional financial resources for the Park, and am working with that coalition to implement that legislation.

5. <u>Provide superb constituent service</u>. An important part of my job is to provide a high level of constituent service. I am proud that my district office is widely regarded as one of the best there is in that regard. We work with community groups and individuals on a broad range of issues and problems,

including rent and housing (see above), problems with public benefits, quality of life issues (e.g., problems with some late-night bars and clubs), utility problems, etc.

#### **TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS**

For 2014 and my coming legislative term, if I am re-elected, I expect that my priorities will be similar to those in the current term. There will be special emphasis on:

- 1. working for a state single-payer health coverage system;
- 2. passing GENDA, getting New York City to liberalize its birth certificate amendment requirements for transgender people to match recent state changes, and promoting Medicaid coverage for transgender hormone and surgical treatment;
  - 3. preventing excessive development;
- 4. promoting affordable housing and strengthening the rent laws (which are up for renewal in 2015); and
- 5. promoting more equal opportunity through support for education, mass transit, a higher minimum wage, and more equitable taxation.
