I believe that the electoral and campaign finance laws in New York State as currently enacted, as well as the policies and practices of the two major political parties, serve to protect incumbents and entrench power in the hands of those who already hold it. Low voter turnout is not a bug of this system, it is a feature by conscious design. And it's not just low-turnout, closed primaries that demonstrate this. The elected officials who collectively control the system prefer that there be as little real voter involvement as possible: almost 1/3 of the members of our legislature attained their office via special election, the vast majority of which occurred in districts where the general election is not competitive, and therefore the county committee process for selecting the candidate on the winning party's ballot was the only decision that mattered. Furthermore, the use of committees on vacancies can serve to allow as few as three party insiders to select their chosen candidate to fill a seat in a regularly scheduled election, a practice that I expect to return to NY if Governor Cuomo maintains his policy of not calling special elections.

I want to go to Albany to work hard, both to deliver results for my constituents and to change the system that leaves New York with such perennially terrible governance. I believe that I am in support of every major initiative that CU supports, but, if I ever ran the zoo, I would go even further. I believe that term limits have served NYC well, and they would serve the state just as well (recognizing that other simultaneous reforms might be necessary to give enough power to the legislature to counter-balance that of the governor, such as control of the first draft of the budget). While corruption has not been banished from the City Council, nor have we achieved some perfect state of universally high-quality legislators, I believe that things are meaningfully better than they were before the combination of matching funds and term limits together gave us a new generation (literally – members are much younger on average than they were before, including multiple councilmembers under 30 elected last

fall) of representatives in City Hall. Furthermore, I believe that positions in the state legislature should be made fulltime, potentially in conjunction with a reduction in its size or even a shift to a unicameral system (I know this is pie-in-the-sky stuff, but dare to dream).

More realistically, we should push for a streamlined voting system in New York that minimizes the number of times that voters are asked to go to the polls while maximizing their opportunities to cast ballots in the reduced number of elections. So we should obviously combine our federal and our state primaries into one and eliminate separate run-off elections in October. We should also introduce early voting, voting by mail, and no-excuse absentee voting. We should have open primaries, or at least allow same-day registration. I am very intrigued by aspects of California's non-partisan, blanket primary system, which I believe does a much better job than ours of recognizing that general elections are simply not competitive in the vast majority of jurisdictions in the state. And I think we should go further, again recognizing that this is not easily done: in a perfect world, we would move city and county elections from odd years to even years to combine them with state and federal elections, we would increase the term length for state senators (or go to a unicameral system), and we would eliminate judicial elections and replace them with an appointments process. Look, I dare to dream on this stuff, but I am also very prepared to work hard, and work constructively with my colleagues in the Assembly, to move the ball forward on incremental reforms.

II. CAMPAIGN PROMISES MADE TO VOTERS (PAST AND CURRENT)

As a candidate who presently does not hold elected office, CU is interested in knowing your top five campaign promises you are making to the voters during this campaign for this position.

If elected, Citizens Union will use these promises to evaluate your performance while in office, as well as, to evaluate your candidacy in the future.

TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS

1. Fight the E 91st St. MTS – it isn't just a NIMBY issue, it is a fiscal, operational and environmental mistake for the entire city. We do not need to move the MTS to someone else's neighborhood; rather, we do not need to build one at all. Manhattan's municipal waste should continue to go by primary truck to existing transfer stations in NJ (not because we hate NJ, but because there are still large industrial zones within a short distance) while the city spends the next few years focused on (i) dramatically increasing our recycling rate (likely requiring changes in the next sanitation worker's contract, which changes would not be unreasonable and which are the norm in most other large US

cities) and (ii) transitioning its garbage truck fleet from diesel to electric and/or CNG engine technologies (there are pros & cons for each, but while each requires a greater up front cost / truck, the annual operating costs are significantly lower, leading to payback periods of 1 to 3 years on the incremental investment depending on relative energy costs vs a 5 to 7 year truck lifespan). I recognize that these are primarily city issues, not state issues, but the state rules over the city, and certainly is heavily involved in the environmental permitting required, in negotiations with NJ, in possibly mandating low emissions technologies, etc.

- 2. Invest in education: public schools in my district are extremely overcrowded (as they are in many parts of NY), and I want to get creative to build more classroom space, particularly for Pre-K (despite UPK's passage, no slots were added in my district for 2014-15 due to lack of space) by pushing mixed use development, getting the state's Educational Construction Fund working again to finance that, and more.
- 3. Economic & housing issues: work to increase the minimum wage (the preponderance of academic research is absolutely on the side of raising the wage and, as a former executive, I have the credibility to argue that in the media and with the business community) and focus on housing affordability as a regional issue, not as just a local issue in my district or even as a citywide issue. We need to encourage increased density around the city and in its suburbs, and I have meaningful ideas as to how to achieve that I would be happy to discuss.
- 4. Work to improve governance on Roosevelt Island: while RIOC is a state agency, and the people of the entire state of NY own its assets and have an interest in the island, the mixed elected / appointed board that our prior governor had agreed to made sense, and our current governor should be following it rather than ignoring it.
- 5. Pass comprehensive campaign finance reform and the full 10-point Women's Equality Act. I put these in 5th place on my list for CU not because I think they are unimportant issues they are very important. I put them here because I am running as a Democrat for the Assembly, and these bills pass the Assembly every year and will continue to do so, with or without my vote. It's the Senate that needs to pass these bills in order for them to become laws. That said, what I can promise that I will do is watch closely, fight hard and speak out if negotiations between the Senate and the Assembly lead to watering down of campaign finance reforms.
- 6. Transportation & infrastructure: I am extremely passionate about these topics, and I plan to dive deeply into the world of the state authorities that rule much of this part of our lives. I want to work on aging and upgrading issues (e.g. fight for state and federal money to upgrade our rail signaling and controls technologies to increase speeds and throughput while improving safety), congestion issues (I am a big fan of Sam Schwartz's revised MOVE NY plan, and I was deeply disappointed when the governor undermined its logic by unilaterally cutting the Staten Island tolls), and road / street safety issues (e.g. adding speed cameras; revising the criminal code to make it a misdemeanor or even low-grade felony to cause bodily injury to a pedestrian or cyclist while breaking any traffic law, such as failing to yield while turning, even if the driver is sober & stays at the scene). Note that this is in 6th place (which you didn't even ask for) because while I can't leave it off my honest list, all of my advisors tell me that voters don't actually vote based on infrastructure issues (and they have polling to back them up).
