ELECTION REFORM

1. What is your position on the redistricting proposition amending the constitution on the November ballot that would create an independent commission with appointees split evenly between the majority and minority parties?	I need more information on the specifics of this proposal.
2. What is your position on restructuring the state Board of Elections and changing the administration of elections by amending the constitution to abolish the strict two-party division of governance and operation?	I need more information on the specifics of this proposal.
3. What is your position on making it easier for candidates to appear on the ballot by lowering signature requirements and utilizing less burdensome witness signature requirements?	Support
4. What is your position on amending the Municipal Home Rule Law to limit the ability of a mayor-appointed charter revision commission to "bump" other local charter amendments from appearing on the ballot?	Support
5. What is your position on automatically granting New Yorkers on parole the ability to vote? Currently those on parole may obtain a Certificate of Good Conduct or Relief to have their right to vote restored, but few of these are granted, and they cannot be applied for immediately upon release.
