one large agency with little to no oversite into the effectiveness of the plan and lacks accountability to any other

agency. It is a grave disservice to the residents of these identified neighborhoods and its perspective workforce,

(which is controlled by oligarchic developers and "pay to play" parties) that such a massive city funded

undertaking lacks an unbiased system of accountability and is being used as a means of forced migration.

I intend on enforcing MIH housing regulations; as well as, instituting an economic investment mandate in conjunction with union labor and local residents funded in part with rental subsidies for a truly 100% affordable plan.
