

I think that the reforms enacted by the council are better than the rules which the council used to follow, but the reforms are very far from perfect. I am in support of a more independent process, similar to the State Legislature's bill drafting commission, because at the end of the day I don't think that politics should ever get in the way of making the city function more efficiently, and a process which gets in the way of good, fair and efficient policy making is one we should do our best to get rid of.

In the current political climate I don't think we should be opening up Pandora's Box. While I support governmental changes to accommodate new policies and adapt to changing times, a Constitutional Convention could roll back hard fought rights like the right to collectively bargain and organize a union or the right to marry whom you choose. There is a process in place to make amendments to the constitution without resorting to electing delegates based on gerrymandered senate district lines or opening up all the progress we've made to being undone or rolled back. I believe that New Yorkers have the right to vote whichever way they think is right when it comes to this issue, the reason why I oppose such a convention is because a constitutional convention can open up the entire state's constitution to a hap-hazardous environment and could ultimately have long lasting effects which hurt every New Yorker, which is something that my campaign opposes. If there are changes needed to our state's constitution then those changes can happen specifically through the state legislature and is something that I would tell my constituents who are considering to vote for a convention. There are existing mechanisms to enact lasting change that are less likely to invite large expenditures by special interests to create chaos and potentially great harm.

Last year, Citizens Union helped craft and push for the enactment of a law that placed political contribution limits and disclosure requirements on nonprofits that are formed by, or affiliated with, elected officials, which helped prevent some significant features of an emerging "pay-to-play" culture in New York City. Do you have any other ideas to further limit such a culture and create a better environment where contributions, either personal or political do not unduly influence the actions of elected officials?

The biggest concern when it comes to pay-to-play is the amount of access moneyed individuals get to an elected official. One way we can at least start to reduce the effects of pay-to-play culture in our politics is something as simple as keeping public logs of visitors to an official's office during their tenure in office. If a lobbyist is meeting with an official the community members have the right to know how often and how long. This is a very basic step, but it is one which will increase transparency and trust in our legislative process. We could also consider limitations on bundling of contribution - in particular from those with business before the city.

TOP FIVE CAMPAIGN PROMISES

1. Fix our subways. The 43rd Council District sits about 7 miles from Manhattan and yet people who live in other states get to work in Manhattan faster than we do. It is absolutely absurd. It's already hard enough for hard-working families to move around this city. Between the long commutes and fare hikes, we are simply not getting the service we need. The people who suffers most from a lack of reliable public transportation are working families, the middle class, and people living in poverty, students and seniors. The people who do not suffer from a lack of reliable public transportation are the people who make the decisions regarding public transportation.

2. Build more schools. Invest in our schools so that our children have the best possible tools at their disposal to help them in their future careers. We have a crisis of overcrowding and often under serviced schools - in particular within schools with a large ESL population. There aren't any schools in District 20 that aren't at least 140% overcrowded.

3. Support small businesses. As a small business owner I know many of the hurdles that face long term struggling businesses. Help local small businesses within our community in order to have an economy which works for the everyday worker.

4. As with most parts of the city, we have a large population of individuals who would like to age in place, and are entitled to world class services and the dignity to do so. Our senior centers deserve increased support and funding and we need to find ways to invest further in transportation services and access to benefits such as SCRIE.

5. Promote a more open NYPD so that any mistrust between the department and the community can be abridged.
