vulnerable populations.

## **TOP FIVE 2017 CAMPAIGN PROMISES OR GOALS**

- 1. Introduce legislation to restrict as-of-right development by incorporating required public review and require public disclosure and reporting of all sales of air rights and lot mergers.
- Support small businesses by implementing a fee for commercial spaces which are intentionally kept empty for long periods, and by creating lease arbitration for independent business owners dealing with unfair rent increases.
- 3. Push for a comprehensive citywide school desegregation plan.

4. Expand supportive housing, particularly for seniors, low-income and homeless New Yorkers.

5. Expand oversight of NYCHA, create greater accountability, and increase the capital repairs budget.
