TOP FIVE 2017 CAMPAIGN PROMISES OR GOALS

1.	I am running to add more pragmatism and transparency to City Hall. I will stand up to my colleagues and the Mayor when appropriate as I am a
	citizen candidate not beholden to anyone on Day 1. I want to bring competent and non-partisan leadership to City Hall. As a concerned citizen
	advocating for greater public engagement, I will represent the views of my District before my own.
2.	I believe we have reached a crisis situation in our loss of Small Businesses. Rent reform is critical to allowing our small businesses to stabilize and
	grow in our community. I will work diligently to get our vacant storefronts filled, and to keep our mom and pop shops thriving in District 4 and throughout
	the City. I support bringing a version of the Small Business Jobs Survival Act to the floor as this legislation has just gotten kicked down the road from
	one administration to the next.
3.	I will fight to preserve our waterways and open spaces. As a waterfront city, we have a responsibility to our residents to optimize the recreational
	uses of our parks and waterways. We also have an equal responsibility to evaluate storm protection measures for those same waterways to be better
	prepared in the next Super Storm.
