CITY COUNCIL REFORM

I believe that anything which makes our City Council members more independent is an important goal. Too often in our legislative bodies, the leadership has a stranglehold - not only on legislation, but also sometimes on how individuals must respond so as not to embarrass or cross their leadership. If they do not follow the Speaker's talking points, they take the risk of having their discretionary funding cut, and any other punitive measures the Speaker feels fit to enforce. An independent bill drafting committee will certainly help, but I fear it will not go far enough. With 51 City Council members all trying to write their own legislation, that committee could quickly be overwhelmed. Also, a strong and independent minded person must chair this committee. Otherwise, the Speaker and other leadership might still be able

to stall an individual Council Member's legislation. There would need to be a safeguard in place so this will not happen. Additionally, Council Members should be encouraged to work together when they are writing similar legislation. Another issue would be the process of getting Council Members' bills to the floor for a vote. I believe the proper method for City Council and the rules they enact would include a discharge process that is simple and easily attainable if the Speaker does not want particular legislation to see the light of day. This will encourage our Council Members to be more independent if they know the legislation they are writing will be given a fair chance.

As a supporter of the constitutional convention, I will ensure that in my campaign materials and in my speeches I will mention the state constitutional convention and how important it is that voters vote yes on this issue. New York State government at all levels is dysfunctional. Our Forefathers understood that there was a danger of government growing too large and too powerful. That is why they wrote into the New York State Constitution that every 20 years we, the People, have the ability to call a state constitutional convention to right some of the wrongs and reduce some of the power that has been co-opted by our elected officials. I will explain in my speeches that this is the only way we can realize many initiatives and adopt a referendum in term limits for state officials. I will work to quell any fear of the unknown. We can, and we will elect smart citizens to go to Albany and enact the proper changes to our government.

30. Last year, Citizens Union helped craft and push for the enactment of a law that placed political contribution limits and disclosure requirements on nonprofits that are formed by, or affiliated with, elected officials, which helped prevent some significant features of an emerging "pay-to-play" culture in New York City. Do you have any other ideas to further limit such a culture and create a better environment where contributions, either personal or political do not unduly influence the actions of elected officials?

Yes. I would require all nonprofits that receive government money to spend at least 70% of all funds to satisfy their mission. I would also eliminate the ability of any elected official to have a paid position in any nonprofit. If the spouse or any other family member is an executive at a nonprofit, he or she will have to submit a conflict of interest notification, just as elected officials do now.

- 5. There may be instances when an emergency referendum needs to be enacted. This might include acts of terrorism, a sudden financial crash, etc. In these cases, there may not be enough time to wait for a vote by the citizens of NYC.
- 9. (B) Yes the chair must have that power for day-to-day operations, however there should be a process in which the committee members can override the chair and call a vote or schedule a hearing on any current issue.
- 17. The reason why I oppose CCRB being able to initiate investigations on their own is because there is already a schism between our police force and our citizens, which needs to be repaired. However, if the CCRB finds an incident that is egregious, it should bring it to the attention of the locally elected official, the police force, or the district attorneys and allow it to take the regular, legal course of action.
- 18. The CCRB is not a prosecutorial arm of our government. Therefore, our District Attorneys, the State Attorney General and other federal/local prosecutors are the proper authorities to handle these situations. However, lying to the CCRB should be treated as falsifying government information, and should be reported to the proper authorities.
- 26. I would oppose urban planners that are employed by NYC. The community boards must be independent bodies and should not be advised by an urban planner that was hired NYC. They must find their own, independent experts.

However, some funding should be added in order for community boards to hire their own, independent urban planners.

TOP FIVE 2017 CAMPAIGN PROMISES OR GOALS

- Often referred to as "Quality of Life" issues, I prefer to refer to these issues as a consideration of our "Level of
 Health and Well-Being." Urinating on the streets, the Marine Transfer Station, lead in the water at many public
 schools and affordable housing buildings, more garbage than ever on our streets and sidewalks, traffic congestion
 caused by double parked trucks and bike and turning lanes these are all situations that release contaminants into
 the air and cause life endangerment. I promise to fight for New Yorkers and make positive changes in these areas.
- 2. Homelessness Over 60,000 homeless people are flooding our streets and shelters. The answer is NOT to add more shelters. Rather, let's subsidize vocational schools and help our able-bodied homeless help themselves. We should help as many New Yorkers as possible to contribute to our society, which will help to stop the billions of dollars needed now to continue supporting our homeless. A large portion of homeless people can and should be working. With proper vocational training, we CAN get our homeless off the streets, out of shelters, and into real jobs.
- 3. Education I am a strong advocate for freedom of choice for education. I believe the cap should be lifted on the number of charter schools allowed in NYC. I come from a family teachers, and I know the compassion they feel for their students. Yet, they are frustrated because they need more money for programming and supplies. Oftentimes it comes from their own pockets in order for their students to receive the best education. I believe a better look at how the budget is allocated is in order. I also do not believe in Mayoral control of schools. There should be a NYC Chancellor of Education who will report to the Mayor, but not necessarily agree with him on every issue.
- 4. Small businesses closing all over NYC I believe the Commercial Rent Tax should be repealed completely. There is simply no reason for it whatsoever. I am an advocate for the Small Business Job Survival Act. Our "Mom & Pop" businesses need our support by driving out the overabundance of formulary businesses on every block. Too many of our streets in the neighborhood are dark at night, because businesses cannot survive and are closing. This brings

- crime, more homelessness, and a decrease in the value of property in the area. I will work to keep our neighborhood open, active, beautiful, and secure by ensuring our small businesses every opportunity to continue thriving, which will, in turn, keep more New Yorkers employed and living better lives.
- 5. While there are still a myriad of issues, including Affordable Housing (we need more!), Riker's Island (I am against closing and in favor of improving its infrastructure and social services), there is an issue that I believe also needs to be addressed: the extreme dichotomy of our current political system in NYC. Many "solutions" to problems are not solutions. Rather, they are an answer to the Progressive Agenda in the areas of economic and social issues. I believe common sense solutions to our issues will win the day, and I will work to find the most fiscally responsible opportunities that will bring New York back to a moderate environment. I believe working together, on both sides of the aisle will afford ALL New Yorkers the best possible outcome. My message is one of inclusion, not exclusion.

III. ETHICAL

REPRESENTATION OF CONSTITUENTS

Citizens Union believes that all New Yorkers deserve to be represented by officials who work for the public interest and honor public trust. With the corruption conviction of recent state legislative leaders, we seek to endorse a candidate who will demonstrate that she/he will honor the full commitment of the oath of office, and will always represent the public interest above all else.

I don't lie. I don't know how! A record of honesty and my good name are what I bring to the table in this election.

As the mother of 6, grandmother of 8, and married for 34 years, my entire life has revolved around putting other people's needs ahead of my own. Over the past 20 years, I have founded four different nonprofit organizations: a school for children with autism, a high school for students with mild learning challenges, a new community center (presently being constructed on the UES), and an organization for women who are in need of marketable job skills in order to enter the workforce. In each instance, I saw an opportunity to help others, and for others to help themselves. My husband and I have raised our children to be honest, independent thinkers who could take care of themselves when they entered adulthood. I believe everyone deserves the opportunity to reach their fullest potential, and the role of government should include offering the right opportunities to do so. That said, I recognize the startling rate at which many of our elected officials are involved in corruption scandals and convictions. It is shameful. As a City Council Woman, I would work to combat corruption by staying in constant touch with my constituents' – and all New Yorkers' - needs and interests, and bringing their wishes to reality through honesty and integrity. The ability to manage opposing points of view is one of my strengths, as well as knowing when to work as a team and when to make an important decision that will affect the lives of many people. It's what I do best. I am a person with a great amount of focus – I see a problem, and I work hard until the problem is solved without sacrificing my integrity.

There is an expression: "Live so that when your children think of fairness, caring, and integrity, they think of you."

I do live by those words, and it is my goal for all New Yorkers to think of our City Council (and hopefully all government!)
as a reliable source for fairness, caring and integrity. I believe that is what our Forefathers intended for our

government and our nation, and it is my promise that I will uphold those values when elected.
