**Question #1:** I support the redistricting proposition of amending the constitution to create an independent redistricting commission. However, I believe commission member appointments of the major and minor political parties, should be made in proportion to their percentage of registered voters among the aggregate registered voters within New York State.

**Question #4:** Those persons on parole should have their voting privileges automatically restored. This remains an especially important issues in communities of color. In order to properly reengage into civil society, they must be able to actively participate in the civic and political affairs of the their community.

**Question #5 –** I support amending the Municipal Home Rule Law to curb the Mayor's powers to usurp pertinent New York City ballot initiatives through the designation of Mayoral Commissions. In some cases, this has been a vehicle to delay the discussion of issues, which were not favored by various Mayoral Administrations.

**Question #12** – I am concerned that the implementation of Instant Runoff Voting will be problematic in its electoral administration and perhaps unintentionally increase the costs of political campaigns. This may prove especially challenging in developing campaign strategies for direct mail and television advertising. Voters wish to have full participation in the electoral process and directly elect the candidates of their choice. We need to place greater efforts in other areas to expand the base of the electorate.

**Question #24:** The established commission for the selection of judges in New York State Trial Courts, must have a stated commitment and operational plan to ensure diversity within the judiciary inclusive of race, ethnicity, gender, sexual orientation, and disability, which is representative of the demographics comprising New York State.

**Question #26:** In my opinion, the New York State Legislature should pass legislation creating a special prosecutor, for the purposes of investigating election law malfeasance claims, or continue the current framework allowing for the United States Attorney to examine these matters. We should attempt to maintain objectivity within the investigation of these matters. In New York State, our Attorney General is an elected position and we must guard against concerns that investigations may be undertaken or prosecutions sought based on political considerations.

**Question #33:** I support maintaining the New York State fiscal year at April 1st. The Governor and New York State Legislature has presently recorded 4 on time budgets. Second, I am concerned that a later requirement would adversely affect the recording of revenues and expenditures in the appropriations process to New York City (which has a July 1<sup>st</sup>) date and other municipalities across New York State.

**Question #34** – The Members of the New York State Legislature should not abdicate our responsibilities as a co-equal part of State Government. Therefore the current and successive Governor's must respect our autonomy, and roles as advocates and ombudsman for our respective communities.
