As a New York State Senator, I feel that the purpose of any elected official should be to serve and protect the will and interest of the people you represent. Leadership is the capacity to translate vision into reality and I believe I've embodied these principles during my time as the Senator of the 23rd District. When the issue of redistricting and the creation of an independent commission to address redistricting in New York was introduced, I voted yes in support of the passage of S3331-Non-Partisan Redistricting Commission. As a previous supporter of the Working Families Party, which I honorably served as an executive committee member in the beginning of its creation, I support choice. I believe third parties joining the electoral process in NY should be encouraged and made easier for potential candidates to appear on the ballot to give voters a greater voice in Albany. Someone once said the key to successful leadership today

is influence, and this is a primary reason I have joined the Independent Democratic Conference to fight on the behalf of all New Yorkers for common sense, bipartisan solutions to New York's toughest challenges. I support the campaign finance measures crafted by the Independent Conference in the Senate, along with other measures it would include the elimination of unlimited contributions to "housekeeping" accounts as well as unlimited expenditures by party committees, this would provide real reform to campaign finance abuses.

In 2011, I voted for and supported the passage of the Public Integrity Reform Act of 2011 which established unprecedented transparency, struck disclosure requirements, and a strong independent monitor with broad oversight of New York State Government. In terms of the state budget, this year I authored a bill in the Senate (S03683-2014) that would permit the State Lottery Commission to sell advertising space on lottery tickets and Quick Draw terminals. The hope is by doing so, the State would be able to raise hundreds of millions of dollars of revenue for education and other expenditures without having to raise taxes by one dime. My overall goal is to have a more transparent, inclusive, and efficient government that is truly representative of all of New Yorkers.

#### TOP FIVE CAMPAIGN PROMISES FROM LAST ELECTION AND ACTION ON THEM

- **1. Improvement in Healthcare access for women.** Voted to pass the Reproductive Health Act out of the Senate Health Committee
- 2. Safe and secure schools, free of bullying and conducive to learning. Co-sponsored the passage of "Dignity for All Students Act" to provide all students with a safe school environment conducive to learning by putting and end to harassment and discrimination. Legislation Bill passed April 30, 2014 establishing speed violation monitoring systems in certain counties including school speed zones.
- 3. Development of green energy initiatives and programs to educate about green energy. Supported NYC Solar energy instillation to be built at Freshkills Park in Staten Island producing enough energy to power more than 2,000 homes increasing city's renewable energy capacity by half.

- **4. Corruption amelioration and transparency in government.** *Legislation Bill passed March 14, 2012 establishes new state assembly and senate districts based on the results of the 2010 census.*
- 5. Protecting and securing retirement plans for my constituencies. Voted nay on legislation bill passed March 14, 2012 that increased the retirement age and increased retirement contributions for public employees who koi the retirement system after April 1, 2012

#### **TOP FIVE 2014 CAMPAIGN PROMISES OR GOALS**

- 1. Furthering Medical Marijuana legalization goals.
- 2. Support fair wages for workers, including raising the minimum wage in NYS.
- 3. Increase financial investment in education.
- 4. Lowering city speed limits to lower injury and death rates.
- 5. Affordability for NY Seniors.
