- 1. **Work to Improve Education** Helped create 4,000 new Pre-K slots, helped save thousands of teachers and school personnel, and fought everyday for our children as Chair of Education Committee.
- 2. **Fight to create jobs and opportunity** Helped start Jobs to Build On to provide community based job training.
- **3.** Enhance open space Installed irrigation in historic Isham Park and worked with Metropolitan Waterfront Alliance to create eco-dock in the Dykman marina.
- **4. Create affordable housing** Help fund Broadway Housing Sugar Hill project providing and working Boys and Girls Club of Harlem to fund affordable housing at old Public School 186. Also, allocated capital funding to CLOTH (Community League of the Heights) to rehab 3 buildings in West Harlem.
